## **FISCAL ANALYSIS**

### **ASSUMPTION**

#### **§ 188.036 - Use of fetal organs or tissue resulting from abortions**

Officials from the **Department of Health and Senior Services (DHSS)** state this proposal adds §188.036.6, which states “no person or entity shall utilize the fetal organs or tissue resulting from an elective abortion for medical, scientific, research, experimental, or therapeutic purposes or any other use.”

The Division of Regulation and Licensure’s (DRL) Section for Health Standards and Licensure (HSL) will be responsible for facility licensing, inspection, and complaints.

It is assumed that the Department can absorb the costs of this bill with current resources. However, if the workload significantly increased or other legislation was enacted, additional resources would be requested through the appropriation process.

**Oversight** does not have any information to the contrary. Therefore, Oversight assumes the DHSS will be able to perform any additional duties required by this proposal with current staff and resources and will reflect no fiscal impact to the DHSS for fiscal note purposes.

Officials from the **Office of Attorney General (AGO)** assume any potential litigation costs arising from this proposal can be absorbed with existing resources. However, the AGO may seek additional appropriations if the proposal results in a significant increase in litigation or investigation costs.

**Oversight** does not have any information to the contrary. Therefore, Oversight assumes the AGO will be able to perform any additional duties required by this proposal with current staff and resources and will reflect no fiscal impact to the AGO for fiscal note purposes.

Officials from the **Department of Commerce and Insurance**, the **Department of Health and Senior Services**, the **Office of the State Courts Administrator** and the **University of Central Missouri**, each assume the proposal will have no fiscal impact on their respective organizations. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

**Oversight** only reflects the responses received from state agencies and political subdivisions; however, other hospitals and colleges were requested to respond to this proposed legislation but did not. A listing of political subdivisions included in the Missouri Legislative Information System (MOLIS) database is available upon request.

No direct fiscal impact to small businesses would be expected as a result of this proposal.


FISCAL DESCRIPTION
