## FISCAL ANALYSIS

### ASSUMPTION

#### § 208.152 – MO HealthNet coverage required for childbirth education classes and doulas

Officials from the **Department of Social Services (DSS), MO HealthNet Division (MHD)** state currently, MO HealthNet does not include childbirth education classes as a covered service, except for doulas who can bill childbirth classes, which started on October 1, 2024. However, some of the Managed Care health plans offer this as an additional benefit at no cost to the patient. If this were a required service, it is possible a state plan amendment and amendment to the 1915(b) Waiver would be needed.

The cost of a study on the impact of childbirth classes on infant and maternal mortality among pregnant women of color would be a one-time cost of approximately \$45,000 (50% GR; 50% Federal) and would be contracted to a vendor.

The cost of adding this service would result in an estimated impact to the Managed Care capitation rates of \$30,000 for FY27 and FY28, a 6.5% medical inflation rate was used. The cost of the actuarial study to evaluate this program change would be \$50,000 (50% GR; 50% Federal) in the first year.

**Oversight** does not have information to the contrary. Oversight notes the proposal does not contain an emergency clause, and therefore, the capitation amount for childbirth classes for FY26 would be \$25,000 ( $30,000/12 * 10$ ), 35.56% GR; 64.44% Federal. Therefore, Oversight will reflect the total MHD FY26 estimates as \$120,000 (\$56,390 GR; \$63,610 Federal) for fiscal note purposes.

**Oversight** notes the [DSS website](#) provides the following:

*Effective for dates of service on or after October 1, 2024, doula services are available to all MO HealthNet (Medicaid) enrolled pregnant women as preventive services when recommended by a physician or other licensed practitioner of the healing arts. This includes prenatal, during delivery, and throughout the 12-month postpartum period. Doula services utilize trained community-based doulas with the aim of improving a range of maternal and infant health outcomes by enhancing the participants relevant knowledge and encouraging healthy behaviors.*

Responses regarding the proposed legislation as a whole

Officials from the **Department of Health and Senior Services** and the **Newton County Health Department** each assume the proposal will have no fiscal impact on their respective organizations. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

**Oversight** only reflects the responses received from state agencies and political subdivisions; however, other local public health agencies were requested to respond to this proposed legislation but did not. A listing of political subdivisions included in the Missouri Legislative Information System (MOLIS) database is available upon request.

Rule Promulgation

Officials from the **Joint Committee on Administrative Rules** assume this proposal is not anticipated to cause a fiscal impact beyond its current appropriation.

Officials from the **Office of the Secretary of State (SOS)** note many bills considered by the General Assembly include provisions allowing or requiring agencies to submit rules and regulations to implement the act. The SOS is provided with core funding to handle a certain amount of normal activity resulting from each year's legislative session. The fiscal impact for this fiscal note to the SOS for Administrative Rules is less than \$5,000. The SOS recognizes that this is a small amount and does not expect that additional funding would be required to meet these costs. However, the SOS also recognizes that many such bills may be passed by the General Assembly in a given year and that collectively the costs may be in excess of what the office can sustain with its core budget. Therefore, the SOS reserves the right to request funding for the cost of supporting administrative rules requirements should the need arise based on a review of the finally approved bills signed by the governor.

FISCAL IMPACT – Small Business

This proposal may increase the number of patients that small business doulas may see.  
(§ 208.152)

FISCAL DESCRIPTION

This bill requires MO HealthNet coverage of doula services and childbirth education classes for pregnant women and a support person. The Department of Social Services is required to study the impact of the childbirth education classes on infant and maternal mortality among pregnant women. This report must be submitted to the General Assembly before January 1, 2028.

The bill adds childbirth education classes to covered services for unborn children enrolled in the Show-Me Healthy Babies program. The bill also establishes the "Missouri Doula Reimbursement Act". Under the provisions of this bill, the MO HealthNet program is required to cover the following doula services:

- (1) A combined total of six prenatal and postpartum support sessions;
- (2) One birth attendance;
- (3) Up to two visits for general consultation on lactation at any time during the prenatal and postpartum periods; and
- (4) Community navigation services, except that those services provided outside any of the above visits or sessions can only be billed up to 10 times total over the course of the pregnancy and postpartum period.

The bill specifies under what conditions a doula is eligible for participation as a provider of doula services and that once enrolled as a provider, a doula is eligible to enroll as a provider with fee-for-service, managed care, and accountable care payers affiliated with MO HealthNet, but that services must be reimbursed on a fee-for-service schedule. (§ 208.152)

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
