ASSUMPTION

Section 227.878 – Road Naming

Officials from the **Missouri Department of Transportation (MoDOT)** state HB 107 is estimated to have a total negative impact on the State Road Fund of \$4,000. This would be a one-time expense as the language requires MoDOT to fund this designation with no costs for sign fabrication and installation recouped through the participation fee. The estimated cost is \$2,000 per sign, with 2 total signs for this designation.


FISCAL DESCRIPTION

This bill designates the bridge on U.S. Highway 54 crossing over the Grand Glaize Arm at Lake of the Ozarks in Camden County as the "Police Officer Phylicia Carson Memorial Bridge". The Department of Transportation will erect and maintain the signs, with the costs paid by the Department.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
