Officials from the **Department of Social Services (DSS)** state any potential impact can be absorbed with current resources.

Officials from the Department of Elementary and Secondary Education, the Department of Public Safety - Missouri Highway Patrol, the Phelps County Sheriff's Department, the Kansas City Police Department, and the St. Louis County Police Department each assume the proposal will have no fiscal impact on their respective organizations. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

Oversight only reflects the responses received from state agencies and political subdivisions; however, other schools and local law enforcement were requested to respond to this proposed legislation but did not.
