**§67.280 – Building Codes**

Officials from the **Office of Administration**, the **Department of Economic Development**, the **Department of Labor and Industrial Relations** and **Kansas City** each assume the proposal will have no fiscal impact on their respective organizations. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

**Oversight** only reflects the responses received from state agencies and political subdivisions; however, other cities and counties were requested to respond to this proposed legislation but did not. Small business contractors who use green or excessive building design and construction practices in their construction, repair or renovations may be impacted from this proposal.


**FISCAL DESCRIPTION**
