## §67.280 – Building Codes

Officials from the **Office of Administration**, the **Department of Economic Development**, the **Department of Labor and Industrial Relations** and **Kansas City** each assume the proposal will have no fiscal impact on their respective organizations. **Oversight** does not have any information to the contrary.
