FISCAL ANALYSIS

ASSUMPTION

Officials from the **Office of the Secretary of State**, the **Missouri Ethics Commission (MEC)**, and the **Office of the State Public Defender** each assume the proposal will have no fiscal impact on their respective organizations.

In response to similar legislation, SB 152 (2025), officials from the **Missouri Ethics Commission** stated the proposal does not have a fiscal impact. If a significant number of entities were to begin reporting such activity as outlined in 130.170 RSMo, additional analysts would be required to assist in providing filing assistance and review of reports filed with the commission. Also, if the Commission identifies significant violations during the process established in Section 105.955.14 (2), (3), RSMo or complaints received increase significantly, an Investigator would be required to provide the proper oversight.

Oversight notes §130.188.1. (1) states “The Missouri Ethics Commission may bring a civil action to enforce sections 130.170 to 130.188. The provisions of section 130.054 and 105.957 to 105.963 shall not apply to violations of sections 130.170 to 130.188.”

Upon further inquiry, the **MEC** assumes that provision removes their investigation ability. Therefore, they would be unable to take anything before the court. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note.

Officials from the **Attorney General’s Office (AGO)** assume any litigation costs arising from this proposal can be absorbed with existing resources. However, the AGO may seek additional appropriations if the proposal results in a significant increase in litigation or investigation.

Oversight notes that the above mentioned agencies have stated the proposal would not have a direct fiscal impact on their organization. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note.

Officials from the **Office of the State Courts Administrator** and the **Missouri Office of Prosecution Services** did not respond to **Oversight’s** request for fiscal impact for this proposal.
