FISCAL ANALYSIS

ASSUMPTION

§§71.012 & 71.015 – Annexation by Certain Cities

Officials from **O'Fallon** assume a cost of over \$100,000 each year.

Oversight has requested additional information from the City of O'Fallon regarding their potential cost of over \$100,000 annually. Upon the receipt of this information, Oversight will review to determine if an updated fiscal note should be prepared and seek the necessary approval to publish a new fiscal note if needed.

Officials from the Little Blue Valley Sewer District (LBV) assume this proposal would require LBV to schedule additional meetings with committees. These committees approve the budget as submitted and recommend passage to the Board of Trustees. If LBV cannot get the meeting scheduled with the other committee members, this would cause a delay in getting the budget to the Board and passage in a timely manner.

Oversight notes the St. Charles County PWSD #2 responded to the proposal, but did not submit a fiscal impact statement. Therefore, Oversight will reflect no fiscal impact for the St. Charles County PWSD #2 for fiscal note purposes.

Oversight assumes that if the municipality annexes an unincorporated area of the city, the municipality would provide for all municipal services to the annexed area (§71.012.6). Oversight assumes there could be increased cost to the municipality for this annexation. Oversight is unable to project a cost for. Therefore, Oversight will show the impact to municipalities as a \$0 to unknown cost.

Oversight states §71.014 in current law provides an additional annexation procedure for cities in certain counties using a petition process rather than a vote of the residents of the annexed area. This proposal would repeal this section and have no fiscal impact on the proposal.

Officials from the Department of Natural Resources, the Missouri Department of Transportation, the Office of the Secretary of State, Kansas City, Osceola, Jackson County Election Board, the Kansas City Election Board, the Platte County Board of Elections, the St. Louis City Board of Elections, the St. Louis County Board of Elections, the Branson Police Department, the Kansas City Police Department, the St. Louis County Police Department, the Metropolitan St. Louis Sewer District, the Osceola Water/Wastewater District, the South River Drainage District, the Wayne County PWSD #2 and Office of the State Courts Administrator each assume the proposal will have no fiscal impact on their respective organizations. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

Oversight only reflects the responses received from state agencies and political subdivisions; however, other cities, counties, county assessors, county circuit clerks, police departments, fire protection districts and utility districts were requested to respond to this proposed legislation but did not. FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

FISCAL DESCRIPTION

Current law provides that a city, town, or village may annex an unincorporated area that is contiguous and compact to its existing corporate limits.

This bill specifies that the term "contiguous and compact" includes a situation whereby at least 25% of the length of the perimeter of the unincorporated area is contiguous with the annexing city, town, or village.

The bill prohibits a city, town, or village from annexing an unincorporated area contiguous to another unincorporated area annexed by the same city, town, or village within 24 months.

This bill requires a city, town, or village that annexes an unincorporated area to provide all municipal services to the annexed area.

Current law provides an additional annexation procedure for cities in certain counties using a petition process rather than a vote of the residents of the annexed area. This bill repeals this annexation procedure.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
