ASSUMPTION

§ 197.062 - Staffing requirements for emergency departments in hospitals

Officials from the **Department of Health and Senior Services (DHSS)** state § 197.062 of the proposed legislation requires hospitals with an emergency room to have “at least one physician on site and on duty who is responsible for the emergency department at all times the emergency department is open.”

The Division of Regulation and Licensure’s (DRL) Section for Health Standards and Licensure (HSL) is responsible for the licensure and regulation of hospitals. HSL may experience minor additional work in terms of complaint investigations related to the provisions of the proposed legislation.

It is assumed that the Department can absorb the costs of this bill with current resources. However, if the workload significantly increased or other legislation was enacted, additional resources would be requested through the appropriation process.

Oversight does not have any information to the contrary. Therefore, Oversight assumes the DHSS will be able to perform any additional duties required by this proposal with current staff and resources and will reflect no fiscal impact to the DHSS for fiscal note purposes.

Oversight only reflects the responses received from state agencies and political subdivisions; however, other hospitals were requested to respond to this proposed legislation but did not. A listing of political subdivisions included in the Missouri Legislative Information System (MOLIS) database is available upon request.

No direct fiscal impact to small businesses would be expected as a result of this proposal.


FISCAL DESCRIPTION
