ASSUMPTION

§68.080 – Waterways and Ports Trust Fund

Officials from the **Missouri Department of Transportation** assume the proposal will have no fiscal impact on their organization. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note.

Oversight notes the ending balance for the Waterways and Ports Trust Fund at the end of January 2025 was \$7,980,142.

Oversight assumes the provisions for §68.080 for this proposal are codifying within statute how the funds are to be managed. Oversight assumes these provisions will not have a direct fiscal impact for this proposal.

Oversight only reflects the responses received from state agencies and political subdivisions; however, other port authorities and St. Louis City were requested to respond to this proposed legislation but did not. A listing of political subdivisions included in the Missouri Legislative Information System (MOLIS) database is available upon request.
