Bill Summary: This proposal prohibits a political subdivision from adopting policies for property transferred by political subdivisions from being used for lawful education purposes by a charter school.

## FISCAL ANALYSIS

### ASSUMPTION

Officials from the **Department of Elementary and Secondary Education** assume the proposal will have no fiscal impact on their organization.

Officials from the **Washington School District** assume, while this bill (as written) does not impact the district financially, the impact on Charter Schools in the community could greatly impact the district. Potentially over \$1 million annually with the loss of 3% of our population and an additional \$2 million for the first year with \$1 million for a loss of 105 students, \$1 million for the reduction/repurpose staff, \$1 million for the impact on their facilities - possible closures and repurposing others due to space.

Officials from the **City of Kansas City** and the **Clay County Auditor** both assume the proposal will have no fiscal impact on their organizations.

In response to similar legislation, HB 1363 (2025), officials from the **East Buchanan Co. C-1 School District** assumed the proposal will have no fiscal impact on their organization.

**Oversight** notes that the above mentioned agencies have stated the proposal would not have a direct fiscal impact on their organization. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note.

**Oversight** receive limited responses from school districts related to the fiscal impact of this proposal. Oversight has presented this fiscal note on the best current information available. Upon the receipt of additional responses, Oversight will review to determine if an updated fiscal note should be prepared and seek the necessary approval to publish a new fiscal note.

**Oversight** only reflects the responses received from state agencies and political subdivisions; however, school districts were requested to respond to this proposed legislation but did not. A listing of political subdivisions included in the Missouri Legislative Information System (MOLIS) database is available upon request.

No direct fiscal impact to small businesses would be expected as a result of this proposal.


FISCAL DESCRIPTION
