FISCAL ANALYSIS

ASSUMPTION

§§1.207, 541.033, 562.071, 563.026, and 565.002 – Protection of unborn children (Abolition of Abortion in Missouri Act)

Officials from **Office of the Secretary of State** assume, each year, a number of joint resolutions that would refer to a vote of the people a constitutional amendment and bills that would refer to a vote of the people the statutory issue in the legislation may be considered by the General Assembly.

Unless a special election is called for the purpose, Referendums are submitted to the people at the next general election. Article III section 52(b) of the Missouri Constitution authorizes the general assembly to order a special election for measures referred to the people. If a special election is called to submit a Referendum to a vote of the people, Section 115.063.2 RSMo. requires the state to pay the costs. The cost of the special election has been estimated to be \$8 million based on the cost of the 2023 primary and general election reimbursements.

The Secretary of State's office is required to pay for publishing in local newspapers the full text of each statewide ballot measure as directed by Article XII, Section 2(b) of the Missouri Constitution and Section 116.230-116.290, RSMo. Funding for this item is adjusted each year depending upon the election cycle. A new decision item is requested in odd numbered fiscal years and the amount requested is dependent upon the estimated number of ballot measures that will be approved by the General Assembly and the initiative petitions certified for the ballot. In FY 2014, the General Assembly changed the appropriation so that it was no longer an estimated appropriation.

For the FY23 petitions cycle, the SOS estimates publication costs at \$60,000 per page. This amount is subject to change based on number of petitions received, length of those petitions and rates charged by newspaper publishers.

The Secretary of State's office will continue to assume, for the purposes of this fiscal note, that it should have the full appropriation authority it needs to meet the publishing requirements. Because these requirements are mandatory, the SOS reserves the right to request funding to meet the cost of their publishing requirements if the Governor and the General Assembly again change the amount or continue to not designate it as an estimated appropriation.

Oversight notes Section C of the proposal is an election clause providing that the provisions of this proposal go to a vote of the people on a regularly scheduled election day. Therefore, Oversight assumes the election clause has no fiscal impact.

Officials from the **Department of Health and Senior Services (DHSS)** state this proposal establishes the "Equal Protection Act," which modifies provisions relating to the protection of unborn children.

The Division of Regulation and Licensure's (DRL) Section for Health Standards and Licensure (HSL) will be responsible for any facility licensing, inspection, or complaint investigation actions that result from the legislation.

It is assumed that the Department can absorb the costs of this bill with current resources. However, if the workload significantly increased or other legislation was enacted, additional resources would be requested through the appropriation process.

Oversight does not have any information to the contrary. Therefore, Oversight assumes the DHSS will be able to perform any additional duties required by this proposal with current staff and resources and will reflect no fiscal impact to the DHSS for fiscal note purposes.

Officials from the **Office of Attorney General (AGO)** assume any additional litigation costs arising from this proposal can be absorbed with existing personnel and resources. However, the AGO may seek additional appropriations if there is a significant increase in litigation.

Oversight does not have any information to the contrary. Therefore, Oversight assumes the AGO will be able to perform any additional duties required by this proposal with current staff and resources and will reflect no fiscal impact to the AGO for fiscal note purposes.

In response to similar legislation from the current session (SB 619), officials from the **Kansas City Election Board** stated it costs \$800,000 to conduct an election in the Kansas City portion of Jackson County. The State would be responsible for their pro-rata share based on voter registration.

Officials from the **St. Louis City Board of Elections** state this bill submits this issue to voters August 2025. Currently, there are no other candidates or issues to be voted on in August of this year; therefore, this bill would generate an election the cost of which is \$500,000, approximately.

Oversight notes Section C of the proposal is an election clause providing that the provisions of this proposal go to a vote of the people on a regularly scheduled election day. Therefore, Oversight will not reflect a separate election cost for the Kansas City Election Board or the St. Louis City Board of Elections.

Officials from the Department of Commerce and Insurance, the Department of Elementary and Secondary Education, the Department of Mental Health, the Department of Social Services, the Office of Administration, the Office of the State Public Defender, the City of Kansas City, the City of O'Fallon, the Jackson County Board of Election Commissioners, the Platte County Board of Elections, the St. Louis City Board of Elections, the St. Louis County Board of Elections, the Newton County Health Department and the Office of the L.R. State Courts Administrator each assume the proposal will have no fiscal impact on their respective organizations. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

Officials from the **Missouri Office of Prosecution Services** did not respond to **Oversight's** request for fiscal impact for this proposal.
