FISCAL ANALYSIS

ASSUMPTION

§59.310 – Documents Presented for Recording

Oversight requested information from County Recorders' Offices, County Clerks and County Commissioners; however, they did not respond to Oversight's request for fiscal impact.

Oversight assumes this proposal modifies the fee schedule for recording a survey, subdivision plat, condominium plat or other drawing depicting the division of land prepared by a professional land surveyor. The bill also modifies the fee schedule for copying a drawing of the above-mentioned divisions of land.

Oversight has presented this fiscal note on the best current information that we have or on prior year information regarding a similar bill. Upon the receipt of agency responses, Oversight will review to determine if an updated fiscal note should be prepared and seek the necessary approval to publish a new fiscal note.

Oversight is unaware of the number of documents that are submitted annually to the Recorder of Deeds Office for each county. There are 114 counties plus the City of St. Louis that have a recorder of deeds office. Oversight assumes this proposal is adding additional documents that may be recorded with a fee charged to those documents. There is the potential for an increase in revenue for each county recorders' offices, but that amount is unknown. Therefore, for fiscal note purposes, Oversight will reflect a \$0 to unknown revenue for county recorder of deeds' offices.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
