### **FISCAL ANALYSIS**

#### **ASSUMPTION**

§182.910 – Reconsideration of Library Materials

Officials from the **Office of the Secretary of State (SOS)** state according to §182.910.6, the Missouri State Library (MOSL) estimates the potential impact as written is between \$0 and more than \$350,000. This is based on digital database acquisition cost and replacing those services if the current service cannot be altered to meet the bill requirements. It may be the MOSL would have to purchase a different database or more than one to replace current services. If no materials are found to be removed the cost is negligible. While some databases do allow curation of material it may not be possible or feasible to create certain restriction or possible to remove certain items necessitating the disconnected use of a particular database. Much would depend upon the issue being challenged.

**Oversight** spoke with SOS regarding their response. SOS states that if this proposal is enacted, there would be an initial unknown cost that could exceed \$350,000. SOS does license with vendors on a yearly basis and would continue to have on-going cost with this proposal. SOS states depending on who they have licenses with would be an unknown on-going cost going forward. **Oversight** does not have information to the contrary and therefore, Oversight will reflect the estimates as provided by the SOS.

**Oversight** also assumes there could be a potential cost to local libraries and schools if more staff time is used to review content or replace current digital services. Therefore, Oversight will reflect a \$0 or unknown cost to local libraries and school libraries for this proposal.

Officials from the **City of Osceola** and the **Rolling Hills Consolidated Library** responded to **Oversight's** request but did not provide a fiscal impact response for this proposal.

Officials from the Department of Elementary and Secondary Education, the Missouri Ethics Commission, Kansas City, O'Fallon, the Jackson County Election Board, the Kansas City Election Board, the Platte County Board of Elections, the St. Louis City Board of Elections, the St. Louis County Board of Elections and the Mid-Continent Public Library each assume the proposal will have no fiscal impact on their respective organizations. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

**Oversight** only reflects the responses received from state agencies and political subdivisions; however, other cities, counties, school districts and public library districts were requested to respond to this proposed legislation but did not. A listing of political subdivisions included in the Missouri Legislative Information System (MOLIS) database is available upon request.

## FISCAL IMPACT – Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

# FISCAL DESCRIPTION

This bill establishes provisions relating to the reconsideration of materials in a public library or public school library.

The bill defines "digital library material" as material including, but not limited to, digital audiobooks, electronic journals, electronic magazines, and other resources that are directly accessible through the public library or school library database, but excluding any online content that is available outside of the public library or school library database or platform.

This bill defines "library material" as any resource in print or non-print format, including, but not limited to, books, magazines, microfiche, microfilm, slides, exhibits, and other materials that are found in a public library or school library.

The bill defines "reconsideration" as a process in which library personnel, public schools, school districts, or library governing bodies review materials in a public library or school library due to a formal complaint filed by a member of the community. The outcome of this reconsideration may include relocating or removing library materials or removing or restricting access to digital library materials.

This bill requires all public libraries and public school libraries to establish a policy outlining the process for library materials and digital library materials to undergo reconsideration based on a complaint made about library materials or digital library materials from a member of the community. Such a policy must be made publicly available as provided in the bill.

A public library or school library will remove library materials from its permanent collection, relocate library materials within its collection, or remove or restrict access to digital library materials within its collection only if the materials have been reviewed in accordance with an established policy for the reconsideration of library materials and digital library materials that complies the requirements of the bill.

To request reconsideration of library materials or digital library materials, the individual making the request must sign an affidavit affirming that: the individual has read or consumed the entirety of the challenged material; and the individual resides in the taxing district of the public library in which the request is made or the school district in which the request is made. Each public library or school library must develop an appeals process for the reconsideration policy that outlines a process for appealing a decision made regarding the removal of library materials or digital library materials, as provided in the bill.

Digital library resources will not track or monitor the access of library materials or digital library materials by individual users, especially minors, including any tracking or monitoring to personalize user experiences.

An individual who is an employee or volunteer of a public library or school library must not be subject to termination, demotion, discipline, retaliation, or any other penalty for refusing to remove library materials or digital library materials before the materials have been reviewed in accordance with a policy that complies with the provisions of this bill.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
