## **FISCAL ANALYSIS**

#### ASSUMPTION

#### <u>§182.910 – Reconsideration of Library Materials</u>

Officials from the **Office of the Secretary of State (SOS)** state according to §182.910.6, the Missouri State Library (MOSL) subscribes to more than 10 databases for an annual recurring cost of more than \$1,000,000. This is based on acquisition costs for online databases and replacing those resources if they cannot be altered to meet the bill requirements. MOSL may have to subscribe to different databases to replace current resources that may have limited curation capability. While some databases do allow curation of material it may not be possible or feasible to create certain restrictions or possible to remove certain items necessitating the discontinued use of a particular database.

**Oversight** notes the cost presented by the SOS is for acquiring online databases and the replacement of existing services. Therefore, Oversight will show a cost of less than \$1,000,000 estimated by the SOS assuming the SOS will have some savings as some services are replaced.

**Oversight** also assumes there could be a potential cost to local libraries if more staff time is used to review content or replace current digital services. Therefore, Oversight will reflect a \$0 or unknown cost to local libraries for this proposal.

Officials from the **Missouri Ethics Commission**, **City of Kansas City**, the **Platte County Board of Elections** and the **St. Louis County Board of Elections** each assume the proposal will have no fiscal impact on their respective organizations. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

Officials from the **Rolling Hills Consolidated Library** assume the proposal will have no fiscal impact, as we already do all of this as a part of the Admin Rule set in 2023.

In response to a previous version, officials from the **City of Osceola** responded to **Oversight's** request but did not provide a fiscal impact response for this proposal.

In response to a previous version, officials from the **Department of Elementary and Secondary Education**, **O'Fallon**, the **Jackson County Election Board**, the **Kansas City Election Board**, the **St. Louis City Board of Elections** and the **Mid-Continent Public Library** each assumed the proposal will have no fiscal impact on their respective organizations. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

# FISCAL IMPACT – Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

#### FISCAL DESCRIPTION

This bill establishes provisions relating to the reconsideration of materials in a public library.

The bill defines "digital library material" as material including, but not limited to, digital audiobooks, electronic books, textbooks, and journals, electronic magazines, and other resources that are directly accessible through the public library database, but excluding any online or digital content that is available to patrons outside of the public library or school library or platform.

This bill defines "material" as any picture, drawing, photograph, motion picture film, videotape or videotape production, or pictorial representation; any recording or transcription; any mechanical, chemical, or electrical reproduction; any stored computer data; or anything that can be used as means of communication. Material includes, but is not limited to, undeveloped photographs, molds, printing plates, stored computer data, and other latent representational objects.

The bill defines "reconsideration" as a process in which library personnel or library governing bodies review materials in a public library due to a formal complaint. The outcome of this reconsideration can include relocating or removing materials or digital library materials.

This bill requires all public libraries to establish a policy outlining the process for materials and digital library materials to undergo reconsideration based on a complaint made about materials or digital library materials from a member of the community. Such a policy must be made publicly available, as provided in the bill.

A public library will remove materials from its permanent collection, relocate materials within its collection, or remove access to digital library materials within its collection only if the materials have been reviewed in accordance with an established policy for the reconsideration of materials and digital library materials that complies the requirements of the bill.

To request reconsideration of materials or digital library materials, the individual making the request must sign a form affirming that: the individual has read or consumed the entirety of the challenged material; the individual resides in the taxing district of the public library in which the request is made; and the individual holds a library card for the public library in which the individual is filing the request for reconsideration.

Each public library must develop an appeals process for the reconsideration policy that outlines a process for appealing a decision made regarding the removal of materials. A record of all appeals requested and their outcomes will be made available by a public library upon request.

Digital library resources will not track or provide third-party notification regarding digital library materials accessed by individual users via public library database. An individual who is an employee or volunteer of a public library must not be subject to termination, demotion, discipline, retaliation, or any other penalty for refusing to remove materials or digital library materials before the materials have been reviewed in accordance with a public library policy that complies with the provisions of this bill.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
