FISCAL ANALYSIS

ASSUMPTION

Section 161.028 - Rue Wells Act

Officials from the **Missouri House of Representatives (MHR)** assume the proposal will have a possible unknown fiscal impact. The legislation doesn't specify whether the House members serving on the board receive reimbursement for reasonable expenses for attending meetings or if they can and will be virtual. MHR assume they will seek travel reimbursement for any days they would have to meet outside of the legislative session. Mileage is paid per round trip. The average mileage for House members is 265 miles and the rate is .655. Reimbursement could be needed for 3 members, \$520.73 (265x.655x3). The estimated impact is unknown because MHR do not know the frequency or timing of any appeals the board may receive.

Officials from the **Missouri Senate** assume a negative fiscal impact to reimburse 3 Senators for travel to Transfer Board meetings. In summary, it will cost approximately \$501.08 each time the board meets to review an appeal.

Officials from the **Office of the Governor** assume this bill adds to the Governor's current load of appointment duties. Individually, additional requirements should not fiscally impact the Office of the Governor. However, the cumulative impact of additional appointment duties across all enacted legislation may require additional resources for the Office of the Governor.

Oversight notes the proposal creates a Transfer Board. Oversight notes the Missouri Senate anticipates cost up to \$520.73 per each meeting for reimbursement of three senators, to handle appeals. Oversight assumes there would be similar cost for the Missouri House of Representatives and Office of the Governor appointee.

Oversight is unsure how many meetings the Transfer Board will be attending per year. Therefore, for information purposes, Oversight reflects meetings cost ranging from 4 times a year to 12 times a year in the table below (to represent meetings attendance 4 times a year or monthly).

Oversight assumes the Missouri House of Representatives, the Missouri Senate and the Office of the Governor is provided with core funding to handle a certain amount of activity each year. Oversight assumes the Missouri House of Representatives, the Missouri Senate and the Office of the Governor could absorb the costs related to this proposal. If multiple bills pass which require additional staffing and duties at substantial costs, the Missouri House of Representatives, the

Missouri Senate and the Office of the Governor could request funding through the appropriations process.

Officials from **East Buchanan Co. C-1 School District** assume this will extend the appeal process, requiring more administrative time to be spent on athletic placements vs. academics. This has an indirect financial impact by causing more administrative time to be spent on non-academic matters.

Oversight assumes East Buchanan Co. C-1 School District could absorb the costs related to this proposal.

Officials from the **Department of Elementary and Secondary Education**, **Office of the Secretary of State**, and the **Joint Committee on Administrative Rules** assume the proposal will have no fiscal impact on their organization. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note.

Oversight received a limited number of responses from school districts related to the fiscal impact of this proposal. Oversight has presented this fiscal note on the best current information available. Upon the receipt of additional responses, Oversight will review to determine if an updated fiscal note should be prepared and seek the necessary approval to publish a new fiscal note.
