## FISCAL ANALYSIS

### ASSUMPTION

#### §77.150 – Water Projects Constructed by Certain Cities

Officials from the **Department of Natural Resources, Kansas City, Osceola, Wayne County PWS#2 and Osceola Water/Wastewater District** each assume the proposal will have no fiscal impact on their respective organizations. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

**Oversight** assumes this proposal repeals the prohibition on the use of indebtedness or taxes for the construction and operation of such projects. Oversight assumes this language is permissive and therefore will not reflect a fiscal impact.

**Oversight** received a limited number of responses from local political subdivisions related to the fiscal impact of this proposal. Oversight has presented this fiscal note on the best current information available.

**Oversight** only reflects the responses received from state agencies and political subdivisions; however, other cities and utility districts were requested to respond to this proposed legislation but did not. A listing of political subdivisions included in the Missouri Legislative Information System (MOLIS) database is available upon request.
