AN ACT

To amend chapter 595, RSMo, by adding thereto one new section relating to a missing and murdered women task force.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Chapter 595, RSMo, is amended by adding thereto one new section, to be known as section 595.327, to read as follows:

595.327. 1. There is hereby created the "Missing and Murdered Women Task Force" to consist of the following members:

(1) The following four members of the general assembly:

(a) Two members of the senate, with one member to be appointed by the president pro tempore of the senate and one member to be appointed by the minority floor leader; and

(b) Two members of the house of representatives, with one member to be appointed by the speaker of the house of representatives and one member to be appointed by the minority floor leader;

(2) The director of the department of public safety or his or her designee;

(3) Two representatives appointed by the director of the department of public safety from among the following:

(a) A member from the Missouri Police Chiefs Association;

(b) A member from the Missouri Sheriffs' Association; or

(c) The superintendent of the Missouri highway patrol or his or her designee;

(4) One or more representatives appointed by the director of public safety from among the following:

EXPLANATION — Matter enclosed in bold-faced brackets ~~thus~~ in the above bill is not enacted and is intended to be omitted from the law. Matter in **bold-face** type in the above bill is proposed language.

- 18 **(a) The attorney general or his or her designee;**
19 **(b) The director of the Missouri office of prosecution services;**
20 **(c) The president of the Missouri association of prosecuting attorneys;**
21 **(d) A judge or attorney working in a juvenile court; or**
22 **(e) An attorney working in the United States Attorney's Office;**
23 **(5) A county coroner or a representative from a statewide coroner's association;**
24 **and**
25 **(6) Three or more representatives appointed by the director of public safety**
26 **from among the following:**
27 **(a) A statewide or local organization that provides legal services to women and**
28 **girls;**
29 **(b) A statewide or local organization that provides advocacy or counseling for**
30 **women and girls who have been victims of violence;**
31 **(c) A statewide or local organization that provides services to women and girls;**
32 **or**
33 **(d) A woman who is a survivor of gender violence.**
34 **2. The task force shall appoint a chair who is elected by a majority vote of the**
35 **members of the task force. The task force shall have an initial meeting before October**
36 **1, 2025. The members of the task force shall serve without compensation but shall be**
37 **entitled to necessary and actual expenses incurred in attending meetings of the task**
38 **force.**
39 **3. The task force shall examine and report on the following:**
40 **(1) The systemic causes behind violence that women and girls experience,**
41 **including patterns and underlying factors that explain why disproportionately high**
42 **levels of violence occur against women and girls, including underlying historical, social,**
43 **economic, institutional, and cultural factors that may contribute to the violence;**
44 **(2) Appropriate methods for tracking and collecting data on violence against**
45 **women and girls, including data on missing and murdered women and girls;**
46 **(3) Policies and institutions such as policing, child welfare, coroner practices,**
47 **and other governmental practices that impact violence against women and girls, and the**
48 **investigation and prosecution of crimes of gender violence against women and girls;**
49 **(4) Measures necessary to address and reduce violence against women and girls;**
50 **and**
51 **(5) Measures to help victims, victims' families, and victims' communities prevent**
52 **and heal from violence that occurs against women and girls.**
53 **4. The department of public safety shall provide administrative support to the**
54 **task force.**

55 **5. On or before December thirty-first of each year, the task force shall submit a**
56 **report on its findings to the governor and the general assembly.**

57 **6. The task force shall expire on December 31, 2027, unless extended until**
58 **December 31, 2029, as determined necessary by the department of public safety.**
