AN ACT

To repeal sections 226.796, 227.299, 227.503, 227.781, 620.467, and 620.2200, RSMo, and to enact in lieu thereof forty-eight new sections relating to tourism.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Sections 226.796, 227.299, 227.503, 227.781, 620.467, and 620.2200, RSMo, are repealed and forty-eight new sections enacted in lieu thereof, to be known as sections 9.005, 9.171, 9.234, 9.292, 9.367, 9.385, 9.386, 9.388, 9.389, 9.401, 9.402, 9.409, 9.416, 10.254, 10.260, 226.796, 226.804, 226.886, 226.1170, 227.299, 227.503, 227.781, 227.830, 227.840, 227.841, 227.857, 227.862, 227.871, 227.875, 227.876, 227.877, 227.878, 227.879, 227.882, 227.883, 227.884, 227.885, 227.887, 227.888, 227.889, 227.892, 227.893, 227.894, 301.3183, 620.467, 620.471, 620.2200, and 1, to read as follows:

9.005. February twentieth of each year shall be known and designated as "John Donaldson Day" in Missouri. The citizens of this state are encouraged to participate in appropriate activities and events to commemorate the life and accomplishments of John Donaldson, one of the best pitchers to play in the Negro Leagues and a member of the inaugural Kansas City Monarchs team.

9.171. November ninth each year is hereby designated as "Links, Incorporated Day" in Missouri. The citizens of this state are encouraged to participate in appropriate events and activities to recognize this international, not-for-profit corporation for its service work and contributions to communities across this state.

9.234. The month of September every year shall be designated as "Ovarian Cancer Awareness Month" in Missouri. Citizens of this state are encouraged to

3 participate in appropriate activities and events to increase awareness of ovarian cancer
4 and the importance of early detection and treatment in saving lives.

9.292. August nineteenth of each year shall be known and designated as "Eddie
2 Gaedel Day" in Missouri in honor of Eddie Gaedel, who as a member of the St. Louis
3 Browns on August 19, 1951, became the shortest player to ever play Major League
4 Baseball. Eddie Gaedel is an important part of baseball history and Missouri sports
5 history. The citizens of this state are encouraged to participate in events and activities to
6 celebrate Eddie Gaedel's contributions to baseball history.

9.367. August sixth each year is hereby designated as "Chris Sifford Day" in
2 Missouri. In the year 2000, an airplane carrying Chris Sifford, along with Governor
3 Mel Carnahan and Roger "Randy" Carnahan, tragically went down and took with it
4 the lives of three great Missourians. Chris is remembered as a loving and devoted
5 public servant who was a friend to all. Missourians are encouraged to reflect on the
6 lives and legacies of these three men and to recognize and appreciate the hardworking
7 public servants of this state.

9.385. October sixteenth of each year shall be known and designated as "Michael
2 Collins Day" in Missouri in honor of Michael Collins, an Irish revolutionary, soldier,
3 and politician who was a leading figure in the struggle for Irish independence.

9.386. The last Saturday in April of each year is hereby designated as "Emmett
2 Kelly Day" in Missouri. The citizens of this state are encouraged to honor the life of
3 Emmett Kelly, who was a famous circus performer, also known as Weary Willie, from
4 Houston, Missouri.

9.388. The second Tuesday of April of each year is hereby designated as "Celia
2 Day" in Missouri in honor of Celia, an enslaved woman who lived in Callaway County.
3 The teachers and students of the schools of this state are encouraged to observe the day
4 with age-appropriate instruction regarding Celia and her story.

9.389. The week in which the second Tuesday of April falls each year is hereby
2 designated as "Human Trafficking Awareness Week". The citizens of this state are
3 encouraged to participate in appropriate events and activities to promote awareness of
4 human trafficking, victim remedies and services, trafficking prevention, and the history
5 of slavery in our state.

9.401. November thirteenth each year is hereby designated as "Believe in
2 Gianna Day" in Missouri. The citizens of this state are encouraged to participate in
3 appropriate events and activities to raise awareness for Sanfilippo syndrome, which
4 causes Alzheimer's-like symptoms in children, and celebrate Gianna Wacker, a
5 Missourian who has defied the odds by exceeding the life expectancy for children
6 suffering from Sanfilippo syndrome.

2 **9.402. May eighth each year is hereby designated as "Amyloidosis Awareness**
3 **Day" in Missouri. The citizens of this state are encouraged to participate in appropriate**
4 **events and activities to raise awareness of this rare and life-threatening disease.**

5 **9.409. 1. January fifth of each year shall be known and designated as "Kappa**
6 **Alpha Psi Day" in Missouri. The citizens of this state are encouraged to observe the day**
7 **with appropriate activities and events to commemorate the founding of the fraternity.**

8 **2. Kappa Alpha Psi was founded on January 5, 1911, at Indiana University, in**
9 **Bloomington, Indiana, by Elder Watson Diggs, Byron Kenneth Armstrong, Guy Levis**
10 **Grant, Marcus Peter Blakemore, Ezra Dee Alexander, John Milton Lee, Henry Tourner**
11 **Asher, Edward Giles Irvin, George Wesley Edmonds, and Paul Waymond Caine.**

12 **3. Founding member Henry Tourner Asher was an educator and instructor at**
13 **Lincoln Institute, now known as Lincoln University of Missouri, in Jefferson City.**

14 **4. Kappa Alpha Psi is the second oldest existing collegiate historically Black**
15 **Greek-letter fraternity and the first intercollegiate fraternity incorporated as a national**
16 **body. The fraternity has over two hundred fifty thousand members with seven hundred**
17 **undergraduate and alumni chapters in nearly every state of the United States, and**
18 **thirteen international chapters in Nigeria, South Africa, Bermuda, Bahamas, U.S.**
19 **Virgin Islands, Panama, United Kingdom, Germany, South Korea, Dominican Republic,**
20 **Abu Dhabi, Canada, and Japan.**

21 **5. Through its worldwide prominence, Kappa Alpha Psi has had a global impact**
22 **on events that affect our local communities and places around the globe. Local chapters**
23 **of Kappa Alpha Psi participate in community outreach activities to feed the homeless,**
24 **provide scholarships to young people matriculating to college, serve as mentors to young**
25 **men, participate in blood drives, and serve as hosts of seminars for public health**
26 **awareness, to name a few. Nationally, Kappa Alpha Psi has provided summer**
27 **enrichment camps and funds for St. Jude Medical Research Center to assist in the fight**
28 **against childhood catastrophic diseases by raising more than one million dollars.**
29 **Internationally, Kappa Alpha Psi members have answered the call to service by proudly**
30 **serving our military in wars since WWI and raising funds to assist those in need**
31 **following natural disasters worldwide, including hurricanes, tornadoes, typhoons, and**
32 **earthquakes.**

33 **6. Kappa Alpha Psi proudly boasts members who epitomize the essence of**
34 **"Achievement in Every Field of Human Endeavor". Some of these members include**
35 **Ralph Abernathy, Wilt Chamberlain, Montell Jordan, Benjamin Jealous, Oscar**
36 **Robertson, Cedric the Entertainer, Arthur Ashe, Mike Tomlin, Gayle Sayers, Adrian**
37 **Fenty, Robert S. Abbott, Bennie Thompson, Donald Byrd, Johnnie Cochran, Ed**
38 **Gardner, Smokie Norful, John Singleton, Tom Bradley, Bob Johnson, John Conyers,**

35 Alcee Hastings, Lerone Bennett, Jr., Kwame Jackson, Bill Russell, Tavis Smiley, and
36 Marvin Sapp.

9.416. June seventeenth each year is hereby designated as "End Neighborhood
2 Gun Violence Day" in Missouri, in honor of Preston Ja'mon "Tink" Jones, Sr. Citizens
3 of this state are encouraged to participate in appropriate events and activities to bring
4 an end to gun violence in our communities.

10.254. The city of Branson is selected for and shall be known as the official
2 "Live Entertainment Capital" for the state of Missouri.

10.260. KSHE 94.7, also known as "KSHE 95", is selected for and shall be
2 known as the official rock radio station of the state of Missouri.

226.796. United States Highway 66 is hereby designated as a historic highway. The
2 department of transportation may place suitable markings and informational signs along
3 United States Highway 66. Such signs shall consist of the usual United States highway sign
4 with the words "Historic Route 66" printed on the face of the sign. ~~[The department shall not
5 use state moneys for such signs, but may accept donations from private sources or federal
6 grants to construct and erect signs described in this section.]~~

226.804. 1. The provisions of this section shall be known and may be referred to
2 as the "Route 66 Signage Maintenance and Enhancement Act of Missouri".

3 2. For purposes of this section, the following terms mean:

4 (1) "Alignment", the specific path or route taken by Route 66 during a given
5 time period. Changes in alignment reflect shifts due to road improvements, bypasses, or
6 realignments over decades;

7 (2) "Centennial celebration", events, programs, and initiatives commemorating
8 the one-hundredth anniversary of Route 66 in 2026, highlighting its historical and
9 cultural importance;

10 (3) "Department", the department of transportation;

11 (4) "Historical roadside features", iconic landmarks, attractions, and
12 infrastructure elements associated with Route 66, including neon signs, motels,
13 bridges, and service stations;

14 (5) "Right-of-way", the publicly owned land on which highways and roads are
15 built, including areas managed by the department of transportation, municipalities, and
16 counties;

17 (6) "Route 66", the historic highway originally designated in 1926, running
18 through the state from St. Louis city to the state line of Kansas west of Joplin,
19 encompassing various alignments over its history;

20 (7) "Signage program", a coordinated effort led by the department of
21 transportation to design, install, maintain, and enhance directional, interpretive, and
22 supplemental signage for Route 66 travelers;

23 (8) "Supplemental signage", additional signs placed alongside standard markers
24 to provide historical context, alignment, and interpretive information about specific
25 locations or features on or near Route 66;

26 (9) "Theft prevention mechanisms", measures implemented to deter the theft of
27 Route 66 signs, including tamper-proof fasteners, special coatings, or micro markings
28 such as "REPRODUCTION" to reduce desirability.

29 3. There is hereby established within the department of transportation the
30 "Route 66 Maintenance and Enhancement Program" to maintain and repair existing
31 Route 66 supplemental signage across the state. The program may be expanded to
32 include enhancement of Route 66 signage, including expanding current Route 66
33 signage beyond rights-of-way to include county and city roads. Such additional signage
34 shall highlight historical roadside features. Moneys allocated to the program as
35 provided in subsection 7 of this section shall be used by the department of
36 transportation to maintain and repair existing supplemental signage and may be used
37 to design, install, and maintain additional supplemental signage on Route 66. Signs
38 shall comply with the standards contained in the Department of Transportation's
39 Manual on Uniform Traffic Control Devices.

40 4. No later than January 31, 2026, the department shall establish guidelines for
41 uniformity of supplemental signage design in coordination with the Missouri Route 66
42 centennial commission established under section 620.2200. The department shall
43 collaborate with counties and municipalities to implement the installation and
44 maintenance of such signage. The replacement of existing signage and installation of
45 new signage shall be completed no later than May 30, 2026. The department shall
46 monitor and maintain such signage as part of its regular infrastructure programs.

47 5. The program shall include measures to implement theft prevention measures
48 for the signage, including anti-theft hardware installation and discreet
49 "REPRODUCTION" markings.

50 6. The department shall seek guidance from the Route 66 Association of
51 Missouri with respect to historical context and expertise on signage placement and shall
52 seek assistance from the Association.

53 7. (1) There is hereby created in the state treasury the "Route 66 Supplemental
54 Signage Fund", which shall consist of appropriations of the general assembly, federal
55 and state grants, and private donations. The state treasurer shall be custodian of the
56 fund. In accordance with sections 30.170 and 30.180, the state treasurer may approve

57 **disbursements. The fund shall be a dedicated fund and, upon appropriation, moneys in**
58 **this fund shall be used solely as provided in this section.**

59 **(2) Notwithstanding the provisions of section 33.080 to the contrary, any moneys**
60 **remaining in the fund at the end of the biennium shall not revert to the credit of the**
61 **general revenue fund.**

62 **(3) The state treasurer shall invest moneys in the fund in the same manner as**
63 **other funds are invested. Any interest and moneys earned on such investments shall be**
64 **credited to the fund.**

65 **8. The department may establish a program to provide matching grants for local**
66 **governments and organizations to address specific signage needs or enhancements**
67 **within their jurisdictions.**

68 **9. The director of the department of transportation shall promulgate any rules**
69 **necessary to carry out the provisions of this section. Any rule or portion of a rule, as**
70 **that term is defined in section 536.010, that is created under the authority delegated in**
71 **this section shall become effective only if it complies with and is subject to all of the**
72 **provisions of chapter 536 and, if applicable, section 536.028. This section and chapter**
73 **536 are nonseverable and if any of the powers vested with the general assembly**
74 **pursuant to chapter 536 to review, to delay the effective date, or to disapprove and annul**
75 **a rule are subsequently held unconstitutional, then the grant of rulemaking authority**
76 **and any rule proposed or adopted after August 28, 2025, shall be invalid and void.**

226.886. The portion of State Highway 19 from State Highway 94 continuing
2 **north to CRD Motley Road in Montgomery County shall be designated the "POW/MIA**
3 **CPT Steven N Bezold Memorial Highway". The department of transportation shall**
4 **erect and maintain appropriate signs designating such highway, with the costs to be paid**
5 **by the department of transportation.**

226.1170. The department of transportation, in consultation with the Ozark
2 **Highland Distillers Guild, shall erect and maintain suitable markings and informational**
3 **signs designating the Ozark Highlands Spirits Region in accordance with the map**
4 **produced pursuant to subsection 4 of section 311.028. Signs shall be located along**
5 **highways approaching or entering the region, with the costs to be paid by private**
6 **donation.**

227.299. 1. Except as provided in subsection 7 of this section, an organization or
2 **person that seeks a bridge or highway designation on the state highway system to honor an**
3 **event, place, organization, or person who has been deceased for more than two years shall**
4 **petition the department of transportation by submitting the following:**

5 **(1) An application in a form prescribed by the director, describing the bridge or**
6 **segment of highway for which designation is sought and the proposed name of the bridge or**

7 relevant portion of highway. The application shall include the name of at least one current
8 member of the general assembly who will sponsor the bridge or highway designation. The
9 application may contain written testimony for support of the bridge or highway designation;

10 (2) A list of at least one hundred signatures of individuals who support the naming of
11 the bridge or highway; and

12 (3) A fee to be determined by the commission, ~~[to cover the costs of constructing and~~
13 ~~maintaining the proposed signs. The fee shall]~~ not to exceed the cost of ~~[constructing and~~
14 ~~maintaining]~~ **the materials needed to construct** each sign.

15 2. All moneys received by the department of transportation for the construction ~~[and~~
16 ~~maintenance]~~ of bridge or highway signs on the state highway system shall be deposited in
17 the state treasury to the credit of the state road fund.

18 3. The documents and fees required under this section shall be submitted to the
19 department of transportation no later than November first prior to the next regular session of
20 the general assembly to be approved or denied by the joint committee on transportation
21 oversight during such legislative session.

22 4. The department of transportation shall give notice of any proposed bridge or
23 highway designation on the state highway system in a manner reasonably calculated to advise
24 the public of such proposal. Reasonable notice shall include posting the proposal for the
25 designation on the department's official public website, and making available copies of the
26 sign designation application to any representative of the news media or public upon request
27 and posting the application on a bulletin board or other prominent public place which is easily
28 accessible to the public and clearly designated for that purpose at the principal office.

29 5. If the memorial highway designation requested by the organization is not approved
30 by the joint committee on transportation oversight, ninety-seven percent of the application fee
31 shall be refunded to the requesting organization.

32 6. Two highway signs shall be erected for each bridge and highway designation on
33 the state highway system processed under this section. When a named section of a highway
34 crosses two or more county lines, consideration shall be given by the department of
35 transportation to allow additional signage at the county lines or major intersections.

36 7. Highway or bridge designations on the state highway system honoring fallen law
37 enforcement officers, members of the Armed Forces killed in the line of duty, Missouri
38 recipients of the medal of honor, emergency personnel killed while performing duties relating
39 to their employment, or state employees killed while serving the state shall not be subject to
40 the provisions of **subdivisions (2) and (3) of subsection 1** of this section.

41 8. No bridge or portion of a highway on the state highway system may be named or
42 designated after more than one event, place, organization, or person. Each event, place,
43 organization, or person shall only be eligible for one bridge or highway designation.

44 9. Any highway signs erected for any bridge or highway designation on the state
45 highway system under the provisions of this section shall be erected and maintained for a
46 twenty-year period. After such period, the signs shall be subject to removal by the
47 department of transportation and the bridge or highway may be designated to honor events,
48 places, organizations, or persons other than the current designee. An existing highway or
49 bridge designation processed under the provisions of this section may be retained for
50 additional twenty-year increments if, at least one year before the designation's expiration, an
51 application to the department of transportation is made to retain the designation along with
52 the required documents and all applicable fees required under this section.

53 10. For persons honored with designations on the state highway system under this
54 chapter after August 28, 2021, the department of transportation shall post a link on its website
55 to biographical information of such persons.

56 11. The provisions of this section shall apply to bridge or highway designations
57 sought after August 28, 2006.

227.503. The bi-directional pedestrian and bicycle path on the **Sam Graves** Heart of
2 America Bridge, which carries Route 9 over the Missouri River in Kansas City, Missouri,
3 shall be designated the "Bob Watts Memorial Bicycle & Pedestrian Bridge". The department
4 of transportation shall erect and maintain appropriate signs designating such pedestrian and
5 bicycle lane, with the costs to be paid for by private donations.

227.781. The portion of State Highway 163 from Mick Deaver Drive to Old Route K
2 in Boone County shall be designated as "Corporal ~~[Steven]~~ **Stephen** Lee Irvin Memorial
3 Highway". The department of transportation shall erect and maintain appropriate signs
4 designating such highway, with the costs to be paid by ~~[private donations]~~ **the department of**
5 **transportation**.

227.830. The bridge on State Highway WW that crosses over the railroad in the
2 **City of Poplar Bluff in Butler County shall be designated the "Senator Bill Foster**
3 **Bridge". The department of transportation shall erect and maintain appropriate signs**
4 **designating such bridge, with the costs to be paid by private donations.**

227.840. The portion of U.S. Highway 54 from one mile east of the bridge over
2 **the Middle River to one mile west of the bridge over the Middle River in Callaway**
3 **County shall be designated as "Celia Memorial Highway". The department of**
4 **transportation shall erect and maintain appropriate signs designating such highway,**
5 **with the costs to be paid by private donations.**

227.841. The portion of State Highway 161 from State Highway Z continuing
2 **north to CRD 403 in Pike County shall be designated as "Adam Ellis Memorial**
3 **Highway". The department of transportation shall erect and maintain appropriate**
4 **signs designating such highway, with the costs to be paid by private donations.**

227.857. The portion of Interstate 49 from U.S. Highway 71 continuing south to the Arkansas/Missouri state line in McDonald County shall be designated the "Deputy Marshal David Thurman Memorial Highway". The department of transportation shall erect and maintain appropriate signs designating such highway, with the costs to be paid by the department of transportation.

227.862. The portion of Interstate 70 from State Highway 131 continuing east to State Highway O/M in Lafayette County shall be designated the "Officer Cody Allen Memorial Highway". The department of transportation shall erect and maintain appropriate signs designating such highway, with the costs to be paid by the department.

227.871. The bridge on Interstate 70 crossing over CST Van Burnt Boulevard in Jackson County shall be designated as "Officer James Muhlbauer K-9 Officer Champ Memorial Bridge". The department of transportation shall erect and maintain appropriate signs designating such bridge, with the costs to be paid by the department of transportation.

227.875. The portion of State Highway 161 from CRD Meadowlark Road continuing north to State Highway CC in Montgomery County shall be designated the "Corporal Richard E Rutherford Memorial Highway". The department of transportation shall erect and maintain appropriate signs designating such highway, with the costs to be paid by the department of transportation.

227.876. The portion of State Highway A from Hopewell Church Road continuing east to State Highway 161 in Montgomery County shall be designated the "PFC Byron Lea Brown Memorial Highway". The department of transportation shall erect and maintain appropriate signs designating such highway, with the costs to be paid by the department of transportation.

227.877. The portion of State Highway F from CRD Long Road continuing north to State Highway V in Montgomery County shall be designated the "LCPL Keo Joe Keshner Memorial Highway". The department of transportation shall erect and maintain appropriate signs designating such highway, with the costs to be paid by the department of transportation.

227.878. The bridge on U.S Highway 54 crossing over the Grand Glaize Arm at Lake of the Ozarks in Camden County shall be designated the "Police Officer Phylcia Carson Memorial Bridge". The department of transportation shall erect and maintain appropriate signs designating such bridge, with the costs to be paid by the department of transportation.

227.879. The portion of State Highway 364 from CST Bryan Road continuing east to State Highway K in St. Charles County shall be designated the "Sergeant Colin I

3 Arslanbas Memorial Highway". The department of transportation shall erect and
4 maintain appropriate signs designating such highway, with the costs to be paid by the
5 department of transportation.

227.882. The portion of U.S. Highway 65 from State Highway YY continuing
2 north to CRD Valley Water Mill Road in Greene County shall be designated the "US
3 Representative Billy Long Highway". The department of transportation shall erect and
4 maintain appropriate signs designating such highway, with the costs to be paid by
5 private donations.

227.883. The portion of Interstate 70 from Carrie Avenue continuing east to
2 Adelaide Avenue in St. Louis City shall be designated the "Police Officer David Lee
3 Memorial Highway". The department of transportation shall erect and maintain
4 appropriate signs designating such highway, with the costs to be paid by the department
5 of transportation.

227.884. The portion of U.S. Highway 50 from CRD Cross Lane Road
2 continuing to CRD Springer Hill Road in Moniteau County shall be designated the
3 "John Lucas Memorial Highway". The department of transportation shall erect and
4 maintain appropriate signs designating such highway, with the costs to be paid by
5 private donations.

227.885. The bridge on Business Loop 44 that crosses over Interstate 44 in
2 Pulaski County shall be designated the "COL Elmer R Parrish Memorial Bridge". The
3 department of transportation shall erect and maintain appropriate signs designating
4 such bridge, with the costs to be paid by the department of transportation.

227.887. The Heart of America Bridge, which carries Route 9 over the Missouri
2 River in Kansas City, shall be renamed the "Sam Graves Heart of America Bridge".
3 The department of transportation shall erect and maintain appropriate signs
4 designating such bridge, with the costs to be paid by private donations.

227.888. The portion of State Highway 139 from CRD Jasper Road/240th Street
2 continuing south to CRD Kelp Road in Sullivan County shall be designated the "PFC
3 LeLand S Deeds Memorial Highway". The department of transportation shall erect
4 and maintain appropriate signs designating such highway, with the costs to be paid by
5 the department of transportation.

227.889. The portion of U.S. Highway 60 from State Highway VV/Mill Street
2 continuing east to CRD Porter Crossing Road in Webster County shall be designated
3 the "William Patrick Thompson Memorial Highway". The department of
4 transportation shall erect and maintain appropriate signs designating such highway,
5 with the costs to be paid by private donations.

227.892. The portion of U.S. 54 from Industrial Park Road continuing east to Business 54 in Pike County shall be designated as "Cotton Fitzsimmons Memorial Highway". The department of transportation shall erect and maintain appropriate signs designating such highway, with the costs to be paid by private donations.

227.893. The bridge on State Highway 291 crossing over the BNSF Railway Marceline Sub in the City of Sugar Creek in Jackson County shall be designated as "Mayor Stan Salva Bridge". The department of transportation shall erect and maintain appropriate signs designating such highway, with the costs to be paid by the private donations.

227.894. The bridge on U.S. Highway 136 crossing over the Interstate 35 in the City of Bethany in Harrison County shall be designated as "Beulah Poynter Memorial Bridge". The department of transportation shall erect and maintain appropriate signs designating such bridge, with the costs to be paid by private donations.

301.3183. 1. Any Missouri resident may receive special license plates as prescribed in this section, for any motor vehicle such person owns, either solely or jointly, other than an apportioned motor vehicle or a commercial motor vehicle licensed in excess of twenty-four thousand pounds gross weight, after an annual payment of an emblem-use authorization fee to The Freedom 13 Organization. The Freedom 13 Organization hereby authorizes the use of its official emblem to be affixed on multiyear license plates as provided in this section. Any contribution to such organization derived from this section, except reasonable administrative costs, shall be used solely for the charitable purposes of The Freedom 13 Organization. Any Missouri resident may annually apply to the organization for the use of the emblem.

2. Upon annual application and payment of a twenty-five dollar emblem-use contribution to The Freedom 13 Organization, the organization shall issue to the vehicle owner, without further charge, an emblem-use authorization statement, which shall be presented by the vehicle owner to the department of revenue at the time of registration of a motor vehicle. Upon presentation of the annual statement and other fees and documents which may be required by law, the department of revenue shall issue a personalized license plate or plates, which shall bear the emblem of The Freedom 13 Organization, to the vehicle owner. Notwithstanding the provisions of section 301.144 to the contrary, no additional fee shall be charged for the personalization of license plates pursuant to this section.

3. The license plate or plates authorized by this section shall be of a design submitted by The Freedom 13 Organization and approved by the department. The plate or plates shall have a black background with white text, shall bear the emblem of The Freedom 13 Organization, shall bear the words "NEVER FORGET" in preference

25 to the words "SHOW-ME STATE", shall be made with fully reflective material with a
26 common color scheme and design, shall be clearly visible at night, and shall be

6 (1) Two public members appointed by the speaker of the house of representatives;

7 (2) Two public members appointed by the minority leader of the house of
