AN ACT

To amend chapter 650, RSMo, by adding thereto one new section relating to unmanned aircraft.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Chapter 650, RSMo, is amended by adding thereto one new section, to be 2 known as section 650.600, to read as follows:

650.600. 1. This section shall be known and may be cited as the "Foreign 2 Unmanned Aircraft Law".

2. As used in this section, the following terms mean:

(1) "Covered foreign entity", an individual, foreign government, or other entity:

5 (a) On the Consolidated Screening List or Entity List as designated by the 6 United States Secretary of Commerce;

(b) Domiciled in the People's Republic of China or the Russian Federation;

8 (c) Under the influence or control of the government of the People's Republic of 9 China or the Russian Federation: or

10 (d) That is a subsidiary or affiliate of an individual, government, or entity 11 referred to in this subdivision;

- (2) "Department", the department of public safety;

- (3) "Director", the director of the department of public safety;

14 (4) "Public entity", the state of Missouri or a department or political subdivision

of the state of Missouri, including all boards, authorities, commissions, agencies,
committees, councils, universities, or other entities created by the Missouri constitution
or by law;

18 (5) "Small unmanned aircraft system" or "system", an unmanned powered 19 aircraft that:

(a) Is operated without the necessity of direct human intervention from within or
 onboard the aircraft;

(b) May be expendable or recoverable; and

(c) Weighs less than fifty-five pounds, including the weight of anything attached
 to or carried by the aircraft.

25 **3.** (1) No public entity shall purchase or otherwise acquire a small unmanned 26 aircraft system that is manufactured or assembled by a covered foreign entity.

(2) No state funds shall be used in connection with small unmanned aircraft
systems manufactured or assembled by a covered foreign entity including, but not
limited to, state funds awarded through a contract, grant, or cooperative agreement.

30 (3) Beginning May 1, 2027, no public entity shall operate a small unmanned 31 aircraft system manufactured or assembled by a covered foreign entity.

(4) The director may waive the provisions of this subsection upon:

(a) His or her review of the necessity to purchase a small unmanned aircraft
 system that is manufactured or assembled by a covered foreign entity due to exigent
 circumstances, for purposes related to counter-unmanned aircraft systems, or for
 criminal investigative purposes; and
