

HB 692 -- INSTALLMENT LENDERS - PAYDAY LOANS

SPONSOR: Murray

This bill applies to pay day loans and reduces the amount of accumulated interest and fees to 65% from the current amount of 75% that a borrower is required to pay on the initial loan amount, for the entire term of the loan and renewals.
