My name is Ben Zeisloft, and I am the Communications Director for the Foundation to Abolish Abortion. We exist to promote public policy that advances equal protection for preborn babies. I am testifying today in firm support for House Bill 1072 and House Bill 1417, because these are the only bills in the state of Missouri that would abolish abortion, by establishing equal protection for our preborn neighbors. Even before the passage of Amendment 3, research shows that there were nearly 1,900 preborn children murdered every year in Missouri, not to mention thousands more murdered by residents of Missouri traveling to other states. Their blood cries out from the ground for justice, and as civil magistrates, you must establish that justice. In past years, the pro-life establishment has worked hard to oppose efforts to abolish abortion, betraying the trust of their supporters who count on them to rescue the innocent from death. The outcome of their leadership, both in Missouri and across the nation, has been complete failure. After more than half a century, our culture is even more hardened in their sin and against their preborn children. If you want proof of this, look no further than the fact that just last year, the majority of voters in your state chose to enshrine child sacrifice into your state constitution. Many decades of pro-life legislation have failed to create a culture of life. As we learned last year, the culture of death has been very much alive and well under pro-life laws, which regulate rather than abolish abortion, and which intentionally refuse to establish justice for the fatherless. The Bible says that a tree is known by its fruit. What has been the fruit of half a century of pro-life cowardice and compromise? Countless thousands of dead babies in Missouri. Countless millions across this country. This is the rotten fruit of regulating abortion rather than obeying God and abolishing abortion: a land drenched in the blood of precious little babies. Today you have the choice to do what is right in the eyes of God, or to do what is right in the eyes of man. What is right in the eyes of man? To keep abortion legal in Missouri by opposing this bill and passing whatever iniquitous decrees the pro-life establishment gives you instead. What is right in the eyes of God? To abolish child sacrifice, without exception or compromise. Please do what is right in the eyes of God by supporting House Bill 1072 and House Bill 1417. I will close with these words from Proverbs 29:25: "The fear of man lays a snare, but whoever trusts in the Lord is safe." Do not fear man, but fear the God who made you, and before whose risen and ascended Son you will one day stand in judgment, to give an account for your works.

Hello my name is Benjamin Belcher I am a lifelong resident of Joplin, MO I am calling on this committee and the rest of the legislature to vote in favor of the equal protection bills. Behind me sits my beautiful wife and my two beautiful children. My wife is 16 weeks pregnant. We used a doppler and heard our baby's heartbeat just yesterday. That baby in her womb is worthy of the same protection under the law whether we decide we love it or want it or whether it was placed there without either of our consent. The same as all of you were worthy of protection. We've all been through these stages of life that we're debating should be ended. My wife also teaches piano to two of my cousin's adopted sons who are now 6 & 7 years old. They were both adopted from parents who were incapable of taking care of them. Would you be able to look those two boys in the eyes, or others like them, and tell them that their parents should have had the right to kill them before they were born? We should not continue to discriminate against our unborn neighbors by failing to provide them the same protections under the law, solely based on their size, location, or stage of development. God considers the unborn to be equal in worth to that of any other human being. In Exodus 21, God gives us a case law of a man who causes a preborn baby to die and the punishment given is to pay for it with his own life. This is the same punishment given to those who murder any other human being who is already born. This shows us that God values the life in the womb the same as any other life. And we are to do the same. God also says in Deuteronomy 22 that those who commit rape are to be given the death penalty. If you want to stop or lower the amount of rape there should be deterrents in place. Jesus says in Luke 17:2 that those who offend little ones would be better off tied to a millstone and drowned in the sea. In Matthew 25, speaking of the final judgement day, Jesus tells us: 41 "Then he will say to those on his left, 'Depart from me, you cursed, into the eternal fire prepared for the devil and his angels. 42 For I was hungry and you gave me no food, I was thirsty and you gave me no drink, 43 I was a stranger and you did not welcome me, naked and you did not clothe me, sick and in prison and you did not visit me.' 44 Then they also will answer, saying, 'Lord, when did we see you hungry or thirsty or a stranger or naked or sick or in prison, and did not minister to you?' 45 Then he will answer them, saying, 'Truly, I say to you, as you did not do it to one of the least of these, you did not do it to me.' 46 And these will go away into eternal punishment, but the righteous into eternal life." Who could be lesser among us than a helpless child in the womb? God tells us that He will take it personally how we treat those who we stand to gain nothing from. You will personally answer to God for what you allowed to happen to the most innocent and defenseless among us. Scientifically, logically, and morally the life in the womb is a distinct human being. We are only asking that it be consistently considered one legally, and to protect them under the 14th Amendment of the United States so that we can stop depriving our preborn neighbors of their lives. Truth is not subjective, and morality is not determined through consensus. Proverbs 11:21 Though hand join in hand, the wicked shall not be unpunished: but the seed of the righteous shall be delivered. Here are a few rebuttals to some arguments that were raised in the

committee meeting that I did not have time to respond to. Objection to the claim of OB-GYN shortage in Missouri. I've looked in to those numbers and the decline we've seen in Missouri is only slightly lower per capita than the rest of the country. Even states with the most liberal of abortion laws are facing shortages. Shortages in Missouri could be due to other factors like it just being a less desirable state to live in. Example: My father in law, helps hire engineers. He says he has trouble getting engineers to move to Joplin. It has nothing to do with laws that could prohibit them from doing their job, and everything to do with Joplin not being as exciting or as nice of a town to live in compared to other options. I believe there was around a 25% drop in new OB-GYN licenses in Missouri when the trigger law took effect after Roe v Wade was overturned. On average, only 29% of OB-GYNs perform abortion services, so the drop in licenses was an intended and expected result. Objection to the argument of rape. Studies have shown only 1-5% (depending on which ones you look at) of elective abortions occur are due to rape. Meaning the vast majority of women who kill their children, do so after they have voluntarily chose to partake in the act of creating children. This is not to say that women who are assaulted do not matter. (I believe women should be protected. A part of doing that is to do what God says to do with rapists and swiftly excute them. There would be no repeat offenders and those who even think about doing so will be detered.) What I am saying is that the exception should not allow the majority of women who were consensually impregnated to murder their unborn children. Objection to the will of the people of Missouri being subverted by passing HB 1072/1417 Amendment 3 only passed by a margin of 1.5%. While the pro amendment 3 side spent roughly 3,000% more getting it through than the opposition could trying to stop it. The people of Missouri were subjected to roughly \$30,000,000 of pro amendment 3 advertising/campaigning vs. Roughly \$1 million of anti amendment 3 advertising/campaigning. Much of this pro A3 money (large portion was from out of state) was spent on ads that deceived Missourians into thinking that Amendment 3 was needed so that women could recieve medically necessary (non elective) abortions. I personally electioneered many days and flipped many voters who told me that they had no idea that our current law already allowed women to receive medically necessary abortions. Here is the portion of the law that allowed for it. <https://revisor.mo.gov/main/OneSection.aspx?section=188.015> (8) "Medical emergency", a condition which, based on reasonable medical judgment, so complicates the medical condition of a pregnant woman as to necessitate the immediate abortion of her pregnancy to avert the death of the pregnant woman or for which a delay will create a serious risk of substantial and irreversible physical impairment of a major bodily function of the pregnant woman; I have underlined "or for which the delay of" because the lie had often been told that medically necessary abortions were only allowed after the circumstances had turned into an emergency for the woman. As you can see, that claim is a bald-faced lie. In reality, Amendment 3 removed most protections and restrictions on abortion. When people heard this, they were disgusted by it and often told me that they had switched to voting no. Thank you for reading.

My name is Kayla McDermott and I am here to testify in support of the abolish abortion bills. I know you will hear a lot of arguments from both sides today but I wanted to share with you a perspective which might not be as common in a healthcare professional. I work in the Emergency department in Joplin MO at Freeman hospital. There I have had countless opportunities to care for women who are having miscarriages. Never once did we as a medical team stop to consider whether we should treat the mother or care for her to the best of our ability because of her baby. In the course of my healthcare profession I have seen many miscarriages and premature deaths of infants when they were born before they are viable outside the womb. Whether it was a life critical emergency because of a ruptured ectopic pregnancy or a premature birth at 24 weeks, our patients have always come first, both the mother and if possible the baby. Abortion does not need to remain legal for women to be cared for medically. For example we had a woman come in to the ER who was suspected of having a miscarriage. Throughout her stay she ended up delivering her 10 week old baby there in the ER. This baby was not viable to live outside the womb and did die. Even at that age where it was tiny enough to fit inside a specimen cup, you could still see the developing eyes and the tiny little nubs that would develop into fingers and toes. Although in this case the baby died the medical team did the best they could to save both the mother and the baby.

I would like to encourage this committee to heartily vote “do pass” on these wonderful pieces of legislation. But it is also tragic in that we even need to be having this conversation. I never cease to be stricken by how many people out there think it is okay to deprive innocent children of personhood and even life itself. In America’s past there were those who considered persons of a particular race to be less than human. They were slaves, owned as property of others. They could be killed by their masters and no one thought anything of it. They often were not killed by their masters because of the economic impact that would have had – there was a financial incentive to keep them alive and perhaps sell them off to someone else. But they were not valued as persons, and their life was not considered an inalienable right. Fortunately – though there is still some work to do - we have corrected that error in our nation’s past with the 14th amendment, which is also the basis of this legislation. More recently the nation of Germany – in the 1930’s and early 40’s – considered Jews to be less than human, deprived of personhood, and even considered “vermin”. Fortunately, the world – led the United States of America – put a stop to that by defeating the Nazi’s in WWII. But here in 21st century America there are many who consider babies as less than human, deprived of personhood, and regulated to being nothing more than a clump of cells. Deprived of their inalienable right to life and liberty. Some would go so far as to say that babies are “vermin”, posing health risk to their own mothers. And tragically, they are often seen as not being financially viable. There are children dying not because of their race or ethnic heritage, but simply because of their age or the fact that they are unwanted . . . But it is past time for us to have a forthright discussion on the fact that every human life is valuable and is to be protected with the same passion and vigor and attention as every other human life. In a culture where everyone says we should “follow the science”, we must acknowledge that the consensus of the scientific community is that life begins at fertilization. According to the American College of Pediatricians . . . “The predominance of human biological research confirms that human life begins at conception—fertilization. At fertilization, the human being emerges as a whole, genetically distinct, individuated zygotic living human organism, a member of the species Homo sapiens, needing only the proper environment in order to grow and develop. The difference between the individual in its adult stage and in its zygotic stage is one of form, not nature.” It is true that at that moment of fertilization, the resulting “embryo” is in fact a human being with its own unique DNA, and nothing else is necessary for it “become” a human. Now, there are those who would claim that because that baby is not “viable” that is, it cannot exist on its own, and without external measures would die. The term “viable” means literally “capable of living”. Some would define it further as being capable of living “under normal circumstance”. But what are normal circumstances? There are people who are only alive because of extraordinary circumstances. My own son, at 30 years old has a pacemaker. It went off Friday night. Is his life not viable because of some extraordinary measure that kept him alive? What about those who depend on dialysis, ventilators, feeding tubes, and other medical equipment in order

I am writing to express my strong opposition to Missouri House Bills 1072 and 1417, both titled the "Missouri Prenatal Equal Protection Act." These bills represent an extreme and dangerous attempt to criminalize abortion and redefine personhood under Missouri law in ways that would threaten the rights, health, and safety of pregnant people and their medical providers. By granting full legal personhood to fertilized eggs from the moment of conception, these bills would rewrite the state's criminal code to allow murder charges for those involved in abortion care, including potentially the pregnant person herself. The bills offer only narrow exceptions for life-threatening situations, and even then, require that "all reasonable alternatives" to save the fetus must have failed, placing physicians in legal jeopardy and delaying urgently needed care. These proposals are not about protecting life—they are about controlling it. They strip Missourians of their reproductive autonomy, endanger lives by deterring medical professionals from providing necessary treatment, and pave the way for investigations and prosecutions after miscarriages, stillbirths, or abortion care. This is not theoretical: in states with similar laws, women have already been jailed for pregnancy outcomes. Let us be clear: abortion is healthcare. Healthcare that Missouri citizens have already voted on and made their choice clear. Missourians believe that abortion and abortion care should be between the patient and the healthcare provider. Legislating reproductive decisions through the criminal code undermines medical ethics, disregards science, and erodes human rights. No person should face homicide charges for making a personal medical decision. These bills would grant full legal personhood to fertilized eggs from the moment of conception. As written, that would not only criminalize abortion as homicide, but also create serious legal risks for patients and medical professionals involved in in-vitro fertilization (IVF). By defining embryos as full legal persons, these bills could make it a felony to discard non-viable embryos, conduct embryo selection, or even store or transfer embryos in standard ways, putting fertility treatments at risk. Missouri families trying to conceive through IVF could find themselves facing heartbreaking legal barriers, delays, or even criminal investigations. These bills would turn one of the most hopeful and sensitive moments in people's lives—starting or growing a family—into a legal minefield. Providers may stop offering IVF services altogether to avoid the risk of prosecution. Personhood bills and IVF can't coexist. Lawmakers should not dictate laws as to what a family looks like and who can start a family. I urge the Missouri General Assembly to reject HB 1072 and HB 1417. These bills do not reflect the values of compassion, privacy, or justice. Missouri residents deserve laws that protect their dignity, their health, and their right to make decisions about their bodies and the growth of their families without fear of criminal prosecution.

Wade guarantees the right to abortion, yet HB 1072 seeks to circumvent this through personhood language designed to ban abortion entirely. Such overreach will embroil Missouri in costly legal battles, wasting taxpayer dollars to defend an indefensible assault on bodily autonomy. Government has no place in the exam room. We must trust women and their doctors—not politicians—to make complex, intimate decisions. HB 1072 replaces empathy with cruelty, science with ideology, and justice with control. It also disregards survivors of rape and incest, dismissing their trauma by mandating forced pregnancy. What of the 12-year-old child impregnated by her abuser? Or the woman whose wanted pregnancy turns lethal? HB 1072 offers them no compassion—only state-imposed suffering. Furthermore, this legislation flagrantly violates constitutional precedent. Roe v. Wade guarantees the right to abortion, yet HB 1072 seeks to circumvent this through personhood language designed to ban abortion entirely. Such overreach will embroil Missouri in costly legal battles, wasting taxpayer dollars to defend an indefensible assault on bodily autonomy. Government has no place in the exam room. We must trust women and their doctors—not politicians—to make complex, intimate decisions. HB 1072 replaces empathy with cruelty, science with ideology, and justice with control. I urge you to reject this dangerous bill. Protect Missourians’ lives, rights, and futures by voting NO on HB 1072.

Personhood from the time of fertilization is a dangerous and highly illogical premise to establish in law. Medically, it makes no sense. It is estimated that 50-70% of fertilized eggs pass in menstruation without implanting in the uterus. So, if every fertilized egg is a "person," HB 1072 would establish that murder is taking place each time a women has a period after having sex. And using protection would not be proof that none of her eggs had been fertilized because no form of contraception is 100% failproof. HB 1072 could also be used to deny access to contraception. Even if the Legislature decided to establish personhood at the time of implantation, the medical definition for the beginning of a pregnancy, all kinds of other issues would arise. For instance: When would paternity be documented? When would child support start? Could a woman get life insurance on a pregnancy, to be awarded if there was a miscarriage? Could a pregnant woman claim the embryo/fetus as a dependent? These are just some examples of complications that arise when non-viable embryos/fetuses are awarded full rights of personhood. Missourians voted in November 2024 to protect reproductive health and choices. And, yes, we knew what we were voting for. Bills like HB 1072 are an affront to majority will and an effort by the anti-choice minority to impose their will. This bill should not be passed by the Committee.
