The Missouri Restaurant Association coordinated with Kansas City Regulate Industries to propose HB1265 to allow for retail by the drink establishments to stay open beyond the normal 1 am - 3 am licensures as regulated by the State of Missouri. This temporary exception allows bar and restaurant owners to stay open to serve the visiting public after games have concluded. A few reasons to support this legislation include: • Most European and South American cities allow for 24-hour consumption of alcohol. • HB1265: This legislation allows retail-by-the-drink establishments to extend their

operating hours during the FIFA tournament, which is essential for maximizing business opportunities.

Late Game Scheduling: Many FIFA games are scheduled to be played late into the evening, necessitating extended hours for businesses to accommodate fans. •Watch Parties: Sports bars and other venues across the state will be hosting watch parties, which will drive additional traffic and economic activity. • Anticipated Visitors: With an estimated 650,000 fans expected to visit Missouri during the FIFA tournament, this is a significant opportunity for local businesses.•Municipal Flexibility: Importantly, municipalities will have the option to opt out of these time extensions if they choose, providing local control over the decision. • Regional Competition: Kansas is already reviewing similar laws to attract visitors to their state, highlighting the importance of Missouri remaining competitive in this regard.Our goal with this legislation is to provide a hospitable environment for the fans visiting our region for the FIFA tournaments.
