However, there are concerning parts to this bill that will have an adverse effect on teacher recruitment/retention and education. I agree that parents should have the right to know what is going on with their children at school, and right now they do. A parent may request to see any materials that are being taught in the schools. They may request alternative assignments if the materials are objectionable to their belief system. I see nothing in this bill that is not already available to parents. This bill is a solution in search of a problem. The section entitled "Educators Bill of Rights" some sections that could help teachers but could be in conflict with the "Parents Bill of Right." Teachers do need protection from harassment from students and abuse from parents. What constitutes "abuse" from parents is not spelled out. The section covering "Participate in or promote a political, social, religious, or ethical position that violates such teacher's personal religious convictions; or (b) Engage in political or social activism during school hours since schools should be free from such activities;" What is activism? Would teaching a lesson on Martin Luther King be considered social activism? Teachers do not take "social, religious" positions in class. They will share a variety of thoughts and then let the students debate and draw their own conclusions. That is exactly what public education should be doing, giving the students a variety of views and allowing the students to choose the view that supports their values.

As a special educator I had to be very flexible with the materials I used in order to provide individualized education to each student. For example, if an approach to teaching a math concept to a student did not work I had to find alternate resources. I often had to create worksheets several times a day for each student. This bill would create an undue burden on teachers already working in overcrowded classrooms. They are underpaid and overworked already. By current law if a parent wanted to see something used to teach a student they just ask and the teacher provides it. Teachers don't have the time or energy to keep up with everything used to teach a class and upload it on a website. Few parents have an education degree and may make uninformed assumptions about curriculum. As a parent in Mo I have asked teachers to show me the curriculum. I learned more from that experience talking to the teacher than reading anything on a website. District curriculum is available now, parents can just ask and have the conversations about how it's used. Curriculum is developed in each district through a process that involves stakeholders. As a community member I am on my local district's curriculum committee so I can provide input and ask questions. Please vote against HB 1287, curriculum is already available online for folks to see. To the Members of the Education Committee.I have concerns about the language of HB1287 as written.Agreed: Unruly students can adversely affect the efficient use of instructional time.-Agreed: parents have the right to know what is going on with their children at school. -The section entitled "Educators Bill of Rights" contains some sections that could help teachers but could be in conflict with the "Parents Bill of Right." -Teachers need protection from harassment from students and abuse from parents but what constitutes "abuse" is not defined. -The language prohibiting teachers from engaging "in political or social activism" is problematic - since "activism" is not defined. (For example - if the current social norm is for students to throw trash on the playground, and people want to enact a change, the language of this bill would prohibit a campaign to reduce litter on the playground, since it could be construed as "social activism." Teachers are interested in allowing for the free flow of ideas, and the seeking of solutions to remedy situations in need of change. Even the changing of behavior of "unruly students" could be viewed as "social activism.")-Well-trained, skilled professional educators are able to help their students understand a variety of perspectives and allow for students to engage in critical thinking, choosing the point of view that supports their values, and engaging in civil discourse to express those views, without denigrating the views of others. -Teachers need professional learning support, not more mandates. They carry the burden of equipping the next generation for success. Lift them up! Parents have the rights enumerated. A parent may request to see any materials that are being taught in the schools. They may request alternative assignments if the materials are objectionable to their belief system. -Teachers and parents working together to help students be successful is the goal and will yield positive results.-I'm not sure how this bill will be helpful to either group, or the students they serve.

Under the pretext of advancing "parents' rights," the bill would undermine students' rights and impose a host of draconian restrictions on teachers and school staff. We strongly urge you to reject HB 1287. American Atheists is a national civil rights organization that works to achieve religious equality for all Americans by protecting what Thomas Jefferson called the "wall of separation" between government and religion created by the First Amendment. We strive to create an environment where atheists are accepted as members of our nation's communities and where bigotry against our community is seen as abhorrent and unacceptable. We promote understanding of atheists through education, outreach, and communitybuilding, and work to end the stigma associated with being an atheist in America. As advocates for nonsectarian public education, American Atheists supports students' rights and opposes efforts to erode the quality of education they receive. So-called "parents' rights" bills place draconian restrictions on teachers and school staff, undermining the quality of education available to students. Public school curriculum is developed by experts professionally trained in education and curriculum development to ensure the best educational outcomes for students across the country. If passed, HB 1287 would invite parents who lack these qualifications to interfere with the normal operations of their children's schools. Their personal objections to certain instructional materials would not only impact their own children but all students. While parents have the right to make decisions for their own families, those rights do not include deciding what is appropriate for all families. Missouri's public schools serve students from diverse backgrounds, encompassing a wide range of beliefs, values, and lived experiences. Classroom curriculum should reflect and respect this diversity rather than being dictated by the preferences of the loudest or most domineering parents. Allowing one group of parents to impose their objections on everyone else undermines the core mission of public education: to provide an inclusive, equitable, and high-quality learning environment for all students.HB 1287 also explicitly endangers LGBTQ+ students by encouraging counselors to disclose sensitive information, even in cases when doing so could put a student in harm's way. By granting parents such broad access to all school records, including medical records, HB 1287 risks endangering students whose parents are not supportive of their sexual orientation or gender identity. LGBTQ+ youth who are not adequately protected from harassment or abuse, including by their guardians, are more likely to suffer lifelong negative psychological consequences. Although parents should generally have access to their child's

medical records, school professionals are trained to recognize signs of abuse and should be afforded the discretion to ensure they are not endangering vulnerable young people. Missouri's public schools are meant to be a "great equalizer," safe and welcoming learning environments where all students can receive a quality education. Lawmakers should not create an imbalance of power between parents' responsibilities to ensure the safety and well-being of their children and the fundamental rights of all students. As a co-author along with several parent volunteers of Kansas City's Parents Bill of Rights, I am in favor of this bill in substance, but I want to speak directly to subsection 8.3, lines 92-95 of this Bill. This restriction on training is uncalled for in this bill. Teachers should have whatever tools are necessary to use in situations that arise in schools, especially in schools that may be highly racially diverse. There are evidence-based practices that teachers can use in discipline or mediation that properly situate race and gender. My daughter has attended diverse schools and there are times when the causes of student disruption have been rooted in discrimination. Teachers should be given adequate training to deal with these situations. This subsection of the bill is worded in such a way that these principles are prohibited. That strips local schools and local parents of potentially beneficial information for no legitimate reason other than bandwagon antics.
