Honorable Chair and Honorable Members of the Committee: My name is Richael Cobler, and I am the Executive Director of Central Regional Dental Testing Service, Inc. (CRDTS), a dental and dental hygiene testing agency which develops and administers clinical licensure examinations as a pathway toward licensure across the nation. My organization and I are opposed to HB 1290. As a national testing agency that has provided excellence in testing for more than 50 years, CRDTS typically works with the state dental boards regarding examination rules and requirements. However, because HB 1290 would create a monopoly by eliminating the CRDTS exams, we feel it necessary to bring some information to you regarding our concerns. It is disconcerting that legislators are entertaining a compact bill that names a specific clinical licensure examination as the only pathway toward compact licensure when nearly every state in the nation accepts other exams and/or pathways. CRDTS submitted a letter in the fall of 2024 to the American Association of Dental Board's (AADB) board of directors, officially requesting they reconsider the language in the compact prior to this legislative session and add CRDTS as an acceptable exam along with the ADEX exam. The response received was that the AADB would not change the language as it was an intentional decision to only accept the ADEX exam. We believe this decision by the AADB to accept only one exam as an arbitrary and capricious decision and a violation of anti-trust laws that is being pushed by a small group of people wanting to create a monopoly. The AADB being introduced as HB 1290 will not promote portability or increase access to dental health care as it claims. By restricting acceptable licensure examinations to a single exam (House Bill NO. 1290, 103rd General Assembly; Lines 92-94 & Lines 113-116) it will actually impede portability.CRDTS administers more than 800 exams in Missouri and surrounding states annually. If portability and increased access to care was the goal of this compact, the CRDTS exams would be included as acceptable examinations within the compact language. One must ask, why a national association whose mission is to "assist dental regulatory boards with their obligation to protect the public" (aadbdentalboards.org/Home/Welcome; accessed 2/19/2025) would align itself with one specific test administered exclusively by one testing agency (ADEX/CWC)? Not only is the AADB promoting a compact that requires the CWC/ADEX exam, but the CWC and the AADB currently share staff who are paid through CWC. The AADB's current Executive Director also works for the CWC (exclusive ADEX partner) as the Director of License Acceptance and Portability. Additionally, the Immediate Past President of the AADB publicly recognized the CWC (exclusive ADEX partner) for a "large donation that enabled the AADB to host the annual meeting in Hollywood, CA." It would appear there is some conflict of interest between the AADB, and CWC/ADEX.Besides the conflict of interest, the AADB's justification that they chose ADEX because it is more widely accepted is irrelevant and unjust as CRDTS is a nationally accepted exam and there are currently other acceptable pathways. Additionally, by its own admission, the AADB did not compare the quality or validity of the exams or

consult any other testing agency when drafting the compact.CRDTS has been developing and administering clinical licensure examinations far longer than ADEX has been in existence. CRDTS was incorporated in Kansas in 1974 and ADEX was Incorporated (also in Kansas) in 2005. Furthermore, CRDTS leadership and examiners were very involved in the writing of the ADEX examination. In fact, the first ADEX examination was administered by CRDTS in Hawaii in 2005 (adexexams.org/FAQ/When and How was ADEX created?; accessed 2/17/2025)Taking the choice away from dental and dental hygiene schools and programs by requiring a certain licensure examination is an arbitrary and capricious decision and we hope the committee will view it as unacceptable and defeat HB 1290.Sincerely,Richael "Sheli" CoblerExecutive DirectorCentral Regional Dental Testing Service, Inc.1725 SW Gage Blvd.
