I am deeply concerned about bill HB1441, which would require the Department to partner with organizations to offer grants for programs encouraging two-parent family formation, maintenance, and reunification. While family stability is important, government programs should not pressure individuals to stay in relationships that may be unhealthy or unsafe, especially for those receiving TANF assistance. The bill does not address the reality of abusive relationships. Encouraging reunification without safeguards against domestic violence could put vulnerable parents and children in harm's way. A government initiative should prioritize the well-being and safety of individuals over the ideal of a two-parent household. Additionally, this bill seems to disproportionately target low-income families, sending the message that those who receive temporary assistance should remain in relationships—regardless of their circumstances—to reduce government costs. This approach is misguided and fails to recognize that financial hardship does not mean a person should sacrifice their safety or happiness. I urge the committee to reconsider this bill and ensure that any family-focused initiatives prioritize individual well-being, autonomy, and safety above all else.

My name is Emily Stoinski, and I am a registered Missouri voter. I am also friend to many incredible men in my life, including men with children and men who wish to become fathers. When I first saw the brief summary of this bill and HB 927, I was extremely curious as I know so many men in Missouri would benefit from support in their journey to being a healthy father. I know that specific services geared towards men can be extremely helpful, and yet, I have concerns regarding this legislation. While bill sponsor Gragg stated on his social media and acknowledgement that sometimes two-parent households are not possible, I do not see this reflected. For some men, divorce is the way that they will be able to keep themselves emotionally and physically safe as they sometimes experience abuse within their marriages. There is already an urging for men to "keep it together" and ensure abuse silently, and I am deeply concerned that this bill does not address these issues and instead assumes that marriage is the issue, not assessing for abuse and supporting their needs to be able to co-parent as a single parent if necessary. I oppose this bill, and I would instead encourage individuals to explore how to expand supports to already existing programs to better reach fathers.
