In St. Louis, the job is much harder than the school I taught in Raytown, MO before a large number of unprepared students of color and some without English as a 1st language slowly entered the school. The job became remedial information for part of the students and grade level for those who had been in the Raytown schools all their school years. I have heard stories from St. Louis teachers about the difficulties they face day after day, yet they are not afforded the same retirement I am. That is unfair and unjust, but you have the power to correct it. It is your moral obligation to do so.
