Furthermore, students enrolled in an MSW program that has pre-candidacy or candidacy status can or will be retroactively recognized as having received their MSW from a CSWE accredited program. It is best practice for MSW students to have the ability to sit for the LMSW exam and engage in clinical supervision to ensure flawless transition into their LCSW licensure. Failure to pass this bill means failure to remove a significant barrier for MSW students, and will stall their progress for months or years in obtaining proper licensure. I am an MSW student preparing to graduate from a program in pre-candidacy/candidacy. If I am unable to sit for my LMSW exam prior to graduation and accreditation, my career plans will be put on hold. I am in support of this bill as it will not only benefit myself, but benefit many other current and prospective MSW students seeking licensure.

I Recently retired from state government and the position I retired from was that of a Regional Manager for the Adult Protective Services program with the Department of Health and Senior Services. As a Regional Manager, I was responsible for all hiring in my region, and receiving applications from individuals with a background in the social services industry was infrequent. We need more people with a passion for social work , especially as our population ages and becomes more vulnerable. I will be graduating from Missouri Western State University (MWSU) this May with my Master's of Social Work which is in pre-candidacy standing with the Council for Social Work Education (CSWE). Unfortunately, in Missouri, we can only sit for the Social Work licensing exam once our school Masters program is accredited by CWSE. MWSU has a successful Bachelor of Social Work program and there is no doubt in my mind or any of my fellow MSW candidates' minds that accreditation from the CSWE will happen next year when they become eligible. The passing of this bill will allow students, like me, to sit for the exam and continue to serve the vulnerable residents of Missouri. I live in the Kansas City area and am close to the Kansas state line. In May when I graduate, I will be able to go to Kansas and sit for the licensing exam as they allow this for programs in pre-candidacy. However, I would rather sit for the exam here, in Missouri, where I live and where I have always worked serving Missourians. I am a recipient of the Grow Your Own grant that Missouri has awarded to MWSU to grow their own social workers. This grant has provided me and many others with the wonderful gift of helping with the cost of our tuition. By passing this bill and ensuring it makes it out of committee you will continue that commitment to us and, in turn, we can take care of the people we should be taking care of-vulnerable Missourians.
