Hello, my name is Dr. Billie McGraw and I am the superintendent of schools at Hamilton R-II School District in rural northwest Missouri. Our district has a planned calendar of 170 days and has made every effort to meet the 169 day requirement for additional teacher funding in the 2025-2026 school vear. We began our year as early as legally allowed, which is two weeks prior to Labor Day, As of today's date, 02/18/2025, we have utilized all of our Alternate Methods of Instruction (AMI) days to the maximum extent allowed (6 days) and have added one additional day to our calendar at the end of the school year. These efforts have allowed us to miss 8 in-person days and still meet the 169 day requirement. As I am typing this, we are experiencing extreme cold and inclement weather in northwest Missouri and my fear is that additional weather days will be needed likely pushing our school year past Memorial Day which causes issues with scheduling summer school and we tend to suffer from major attendance issues when school is held after Memorial Day. This winter has been daunting in my region and across the state. Hamilton R-II and many other district's around the state have tried in earnest to meet this new requirement, but must always prioritize the safety of students and staff above all else. The passage of HB 368 would reward the efforts of our students and staff who have done their AMI work while recognizing that we are making our best effort to comply with the spirit of the 169 day rule while maintaining the safety of our students and staff as a top priority. Thank you for your time in reading this testimony and your consideration in supporting HB 368. On behalf of Hamilton R-II School District, we truly appreciate it.

I would like to express my gratitude to the state legislature for considering HB368. As the Superintendent of the Chillicothe R-II School District, one of the most challenging decisions I face is determining whether to hold school or cancel classes when weather conditions pose potential lifethreatening risks.Balancing the imperative to educate, provide meals, and offer a safe environment for our children against the dangers of transporting students to school is a complex dilemma. This is particularly concerning when we must ask our youngest drivers to navigate hazardous road conditions or endure dangerously low temperatures. In December 2023, the Chillicothe R-II Board of Education approved a 170-day calendar, which includes 1,125.6 hours of instructional time for the 2024-2025 school year. Additionally, I submitted a plan to the Department of Elementary and Secondary Education (DESE) and received approval for 36 hours of Alternative Methods of Instruction (AMI) days. This year's weather in Chillicothe has been exceptionally severe, featuring a blizzard, an ice storm, and dangerously cold temperatures. As of today, our district has missed eight days of school, exhausting all of our AMI days, and we have utilized an additional day to meet the 169-day requirement established in SB 727. Therefore, days of school will need to be made up, for the district to receive the needed funds to assist with teacher salary increases. We have limited options for adding more days to the calendar, which would necessitate moving and disrupting our summer school program. Furthermore, adding days after Memorial Day presents challenges for attendance and engagement, as motivation tends to wane during this period, leading to likely low attendance and disappointment due to the delay of summer. My district, along with many others across the state, has made earnest efforts to meet this new requirement while always prioritizing the safety of our students and staff above all else. The passage of HB 368 would reward the efforts of our students and staff who have diligently completed their AMI work and recognize that we are making our best effort to comply with the spirit of the 169-day rule. Extending the school year past Memorial Day presents significant challenges, including decreased attendance, disruptions to family plans, and a decline in student motivation and engagement. These factors hinder the effectiveness of additional instructional days and create logistical burdens for both families and staff. Avenue City is not the only district facing this dilemma. Across Missouri, schools are struggling to balance state requirements with the realities of weather-related disruptions. We must recognize and reward the diligent efforts of students, teachers, and administrators who have done "the work" and demonstrated a genuine commitment to meeting the spirit of the 169-day rule. Above all, student safety must remain our top priority. HB 368 acknowledges the unpredictable nature of weather-related challenges and ensures that schools are not unfairly penalized for circumstances beyond their control. I urge policymakers to support this legislation and provide districts with the flexibility needed to maintain both educational integrity and student wellbeing.
