When I graduated from St. Louis University, I sought employment as a teacher with the same educational system that had empowered me to do well and live a good, wholesome life. I worked hard and earned additional certifications and degrees throughout my tenure as did hundreds of my fellow retirees.For nearly two decades, the members of our retirement system, PSRSSTL, have not received a cost-of-living adjustment (COLA). I spent 26 years of my life as a dedicated educator. Can you imagine that our retirement system has not provided our members with incremental increases for about the same amount of time I spent working in our school district? With inflation steadily rising, our retirement funds remain stagnant. Not only are we not receiving an increase to keep up with inflation, but we are really losing money because as our buying power is unable to keep up with the increased costs, rising taxes and medical costs take huge chunks out of retirement monthly payments which further decreases our ability to buy quality food, fruits and vegetables, live in decent housing, buy gasoline, enjoy social outings like movies and the symphony, etc. Many of us are one emergency away from financial disaster, poor health, and being a burden on our families or the governmental systems in place to help those who are indigent.
