On behalf of OATS Transit, I want to ask you to restore \$5 million back to House Bill 4, which includes MoDOT's budget appropriations. This would bring the total back the current level of \$11.7 million.Last year, OATS Transit provided a million trips to get people to dialysis, to work, to their doctors, the grocery store, the pharmacy, senior center, sheltered workshops, and anywhere else they need to go.OATS Transit was founded right here in central Missouri 54 years ago by a group of volunteers who saw the need for transportation in rural communities. At the same time, a similar initiative was happening in the bootheel which resulted in Southeast Missouri Transportation Service. This makes Missouri unique in that we have not just one but two of the largest and oldest rural providers in the nations - OATS and SMTS - who, along with dozens of other providers means we have public transit in every county - regardless of how rural that county is. Not every state can boast this and it is something we as Missourians can be proud of. Unfortunately, due to lack of funding, some of these counties are not served very frequently with some of our more rural service areas getting only one or two trips a month. If you are dependent on transit to get to the doctors or to get your groceries that is not enough. And it certainly doesn't help someone who needs affordable public transit to get to work. During his State of the State address, Governor Kehoe outlined his budget requests including a cut of \$5 million to state transit operating assistance, almost 50 percent. The SFY 2026 Missouri Highway and Transportation Commission request was \$11.7 million for Missouri transit. This request included \$10 million from General Revenue and \$1.7 million from the State Transportation Fund. This has been the funding level since 2023. On behalf of the thousands of rural Missourians who rely on transit, I'm here today to ask you to prioritize transit and restore the \$5 million from General Revenue to House Bill 4 for a total of \$11.7 million. I cannot stress enough how important the state assistance funding has been for us transit providers. MoDOT allows for flexibility in how we can use the funds; although we at OATS have been using it to match federal operating grants, we can also use it to match federal capital grants for new vehicles. As we come out of the supply chain issues and vehicles are now available, this flexibility will be a game-changer for us. Next year, we anticipate needing to replace 99 vehicles with an average age of 10 years and more than 150,000 miles on the odometer. Just 5 years ago, the average cost to replace a vehicle was \$55,000 requiring \$11,000 in local match. This cost has jumped to over \$100,000 requiring an average of \$20,000 - \$22,000 in match per vehicle. The need for public transit in rural areas was identified back in 1971 and Missouri led the way in developing the solution. I ask you to continue leading the way by showing support for this service that is vitally important to many of your constituents.
