came into being in recent years, they formerly existed as five distinct regional dental examining agencies thus their current names reflect the five merging into two separate agencies. CITA: the Council of Interstate Testing Agencies; CDCA: the Commission for Dental Competency Assessments formerly known as NERB, the Northeast Regional Board; CRDTS: Central Regional Dental Testing Services; SRTA: States Services for Testing and Assessments, formerly known as the Southern Regional Testing Agency, and WREB: Western Regional Examining Board. ADEX stands for American Board of Dental Examiners a newer (as compared in age to the former five distinct regional examining agencies) organization that develops and administers clinical licensure exams for dentists and dental hygienists. ADEX is often closely associated with CDCA which was the first examining agency to utilize the ADEX exam. Currently, CDCA-WREB-CITA utilize ADEX services.
