Due to the ambiguity in Missouri election law, county election officials have been inconsistent in their understanding and enforcement of the directives under RsMO 115,105, which govern the conditions under which a Challenger is allowed to be present to observe election processes. In some Missouri counties, duly designated Challengers are prevented from entering absentee voting locations, while at the same time other counties are allowing Challengers to be present to observe. This discontinuity has created another layer of mistrust for election officials and our electoral system. Each and every Representative believes that trust in our elections is of paramount importance. The passage of HB 638 will help create a consistent understanding of the law between election officials and among Missouri voters, as well as clarify the intent of the law, which is to uphold the public's right to monitor the legality of our electoral processes. I am the Boone County Republican Central Committee Chair. Last October-November we had early absentee voting. Votes are counted and left on flash drives which are not entered into the air gap computer terminal until the night of the election after 7pm. But they are counted and stored because they are put through the tabulation machines. Boone Cty, MO has ES&S Electronic voting systems. Under EAV, they didn't do a sample of the approx 30,000 ballots for the Nov 5th election to hand audit, because the Election Director said the statutes didn't say to. We also have them putting only one set of initials on ballots when cast even though the statute says there has to be two sets Bipartisan. This bill needs to include EAV Watchers and Challengers Revised Missouri Statute says they can be wherever votes are counted, and this is the statute with which our challengers and watchers were allowed in EAV. Why wouldn't the same election statutes apply to EAV that apply to the actual Election Day? This makes no sense they they aren't but the precedent has been set by Boone County Missouri Republican Committee and Election Verification Board for EAV watchers and challengers and our findings resulted in a 45 page challenge packet turned into the DOE of Boone County, the SOS's office, the DOJ and the FBI following proper procedure. The election law needs to be updated and include a clause that Watchers and challengers are also allowed for municipal elections as well. It's a loophole that was found today February 24, 2025. Let's fix this for free fair legal and accurate elections for our future. Anyone saying no to these changes doesn't want transparency, and I would question their motives for that. StCharles County Election Director Kurt Bahr needs to be held accountable so any election director or county clerk involved in these elections needs to have a specific consequence in this bill also. No teeth no one cares to follow a statute in my humble opinion. I pray you figure out how to remedy EAV election integrity as soon as possible, considering it starts 25 Feb 2025 prior to the Columbia Mayoral election or any other taxation issue is placed on the ballot. Thank you for your time today and again I pray you can make this bill whole and comprehensive for EAV related to same rules as Election Day!

State statute 115.105 makes it clear: "The chair of the county committee of each political party named on the ballot shall have the right to designate a challenger for each polling place, who may be present until all ballots are cast on the day of election. Missouri doesn't have one-day elections. We have 6 weeks to vote before every election. Poll challengers are citizen volunteers who believe that election integrity is paramount in preserving our Republic and that the rule of law is being followed. As an election judge for many years, I have appreciated seeing poll challengers and watchers, especially during the 2024 Presidential election which was incredibly busy, even during the early voting weeks. We need more than just election judges monitoring the elections. When there are voters lined up out of the door, election judges don't have the ability to watch for irregularities or suspicious activity. Poll challengers and watchers provide extra surveillance and extra eyes and ears to ensure our elections follow the laws, even during absentee/early voting! I support House Bill 638 because if we don't have lawful elections, we don't have a true representative democracy.

I wanted to share concerns that I and other election authorities have regarding HB 638. This would allow challengers to be present during the absentee voting period. In 107 counties, the elections are conducted by County Clerks. In many of those counties, space is incredibly limited. To have additional people in the office space, potentially in close proximity to voting equipment or in the voting area where they could unintentionally see how a voter has marked their ballot, is in direct opposition to the guiding principles of the MO Association of County Clerks and Election Authorities – to conduct fair, accurate, transparent and secure elections. When challengers are at the polls, they are in a designated space away from the secure voting area. In our offices, anything behind the counter that separates employee workspace from the public is part of the “secure voting area”. It’s where we store our unvoted ballots, where we maintain our tabulator that absentee voters cast their ballots into, where voters that have moved from one MO county to another are having their information updated, where we are processing absentee ballot applications and ballot packets to be mailed out. Additionally, other daily work is being conducted – including payroll with sensitive employee information. We just saw an unprecedented number of voters cast in person absentee ballots during the two week no excuse absentee period for the November 2024 election. In Johnson County and other counties across the state we often had lines at the door before we opened each morning and didn’t finish voting our last voter until thirty minutes to an hour after normal closing time. Our voting booths were at capacity throughout the day and we often had a bottleneck of voters waiting for an open booth. As I think back on what those two weeks looked like – I’m not sure where I could accommodate one extra person, let alone two or three if all of the established parties decide to appoint one. As this bill is considered, I hope that legislators will keep in mind how this would function in their own Count Clerk’s office.
