LWVMO is concerned about a couple of provisions of HB 660. Prohibiting a political subdivision (such as a school district) from submitting a new or increased tax proposal for two years if it failed to pass the first time is overly restrictive on the local subdivision. For example, suppose the vote to build a new school due to overcrowding closely failed, the school board might reassess the plan to reduce the cost somewhat or address the reasons for the failure. Waiting two years to solve the problem being
