Please consider the damage that tax credits and other forms of vouchers to be used for private education has caused to the public school system in other states. Rural districts are disproportionately impacted because (1) there are no other options for school within a practical distance and (2) any loss of funding in rural areas has a heavier impact on the functioning of those schools that depend more on state and federal versus local funding. Vouchers have been shown to lead to discriminatory practices that disadvantage those of minority races or ethnicities, non native English speakers, and children with exceptional/special education needs. Vouchers do not cover the cost of private education and therefore vouchers do not make private education accessible to those who do not have higher socio-economic status. Additionally, private schools will be receiving public funds from taxpayer money without being accountable in any of the ways that public schools are held accountable for performance, hiring qualified teachers, meeting state standards, and serving all students. Please consider the negative ramifications of vouchers in Arizona, Texas and Florida where vouchers have gutted state budgets and public school funding; Iowa where private schools have raised tuition in response to their already-attending families getting vouchers (basically coupons) to attend; and the fact that when voters get to decide when vouchers are on the ballot, **VOUCHERS GET DEFEATED** as in Colorado, Kentucky, and Nebraska. A vote in support of HB 77 is a vote to kill public schools. Please do not support it.

I am submitting testimony today on behalf of Missouri Homeschool Alliance. We administer a facebook group with 4,121 member homeschool families throughout the state of Missouri, as well as a growing network of paid members in our organization. We are a registered non-profit organization that seeks to keep homeschooling parent-directed and parent-funded. We are testifying for information only re: HB77. As the bill was originally written, it included on line 32 a definition of "Qualified school" to include a home school as defined in section 167.012, as well as an FPE school as defined in section 167.013. As a homeschool organization, we are opposed to the idea of a tax credit for homeschool. In Missouri, homeschoolers do not register with the state, and by creating a tax credit, we would be in effect, creating a means of backdoor registration. Those who support this bill would say that the tax credit would be optional, and those who do not wish to participate would be free not to do so; however, through our membership in the National Alliance of Homeschool Leaders, the Home School Legal Defense Association, and our relationships with homeschool leaders in other states, we understand that in other states where voluntary tax credits have been implemented, calls for stricter regulation of ALL homeschool families have quickly followed. We are opposed to tax credits for homeschooling. Further, we would assume there will be additional requirements for participation in the program that would be outside of our statutory requirements for homeschooling, once the Department of Revenue promulgates the rules. We would anticipate that it would be likely that only non-religious, "approved" curriculum and expenses would be eligible for the tax credit, allowing the State to dictate the course of study for homeschoolers, as well as allowing the State to pick winners and losers in the world of curriculum publishing. We are opposed to any increased regulation for homeschool families in Missouri. In 2024, the passage of SB727 created the new category of school called FPE. This new category was created for just such a situation--to allow people who choose to educate their children in the home to receive funding from the state. Finally, we are opposed in general to any refundable tax credit system that creates a new educational welfare program, but if it is the intent of the committee to pass a tax credit, it is our desire to see any references to homeschool removed from the legislation, and to replace it with FPE school 167.013. After conversation with the bill sponsor, it is my understanding that she intends to submit an amendment to remove homeschool and instead reference FPE school alone. We would appreciate this specific language, which we feel is vital for protection of traditional homeschool freedoms. While we don't support the bill in its entirety due to the nature of the refundable tax credit, we are quite appreciative of Representative Loy's willingness to hear our concerns about the inclusion of home school in the tax credit program. We have the FPE school designation in our law, RSMo 167.013, and we would encourage this committee to take up the bill with Representative Loy's amendment that utilizes that designation as intended, and excludes homeschool under RSMo 167.012. Thank you for your attention to our concerns, and I would welcome any
