He has donated \$250 million to the Sixteen Thirty Fund, which has spent \$130 million on ballot measure campaigns, including in Missouri. In 2024, the foreign-backed Sixteen Thirty Fund spent more than \$8 million supporting Prop. A and Amendment 3. This is commonsense legislation that has been passed in other states. Missouri's Constitution should not be subjected to the whims of Foreign Nationals.
