If we were only required to keep 1 book in City Hall that would reduce our cost by approximately 40%. While that isn't a large sum of funding, every penny counts. Those funds could be applied to the budget of another department for a more crucial expenditure. Any assistance provided to help municipalities save money in one area, can increase the budget in another crucial area that can better serve the public.
