Dear Members of the House Budget Committee, My name is Stuart Duncan, President of Chesterfield Sports Association a Non-Profit 501(c)(3) organization that owns and operates The Beal Center in Chesterfield, MO. With your support, The Beal Center was built and opened in March 2023. We are seeking funding for \$500k to help build out and expand our parking space that will allow The Beal Center to utilize its full potential and deliver a great economic impact to the local community and the State of Missouri. The Beal Center (named after Bradley Beal, Chaminade graduate and current NBA Player), was built to offer a home for the Missouri Youth to play the sport they love in a state-of-the-art and safe facility. The Beal Center offers nine (9) basketball courts that can convert to eighteen (18) volleyball courts. The Beal Center currently runs events 48 of 52 weekends annually. The economic impact in just the first 2 years is well over \$25M. That challenge we are facing is the lack of parking. Since the facility was built with only 525 parking spaces, we are limited in being able to offer the full use of the facility. To attract the larger national (Nike, Adidas, Under Armour, etc.) events, we need to have 800-1,000 parking spaces. To that end, we recently purchased an additional 10.02 acres adjacent to our building but need additional funding to build out the parking lot. With the additional parking we can maximize the use of all courts, bring more out of state visitors and drive a larger economic impact to the State of Missouri. Thank you for your support!
