1) ****Section 210.030**** is overly broad. It extends the scope of STD testing and treatment for pregnant and postpartum women by adding a mandatory test at 28 weeks gestation and requiring treatment for any positive results without any stipulation for obtaining consent. There are also no penalties outlined for not securing consent. 2) ****Section 338.010****, line 13, extends the deadline for FDA approval of vaccines that Missouri pharmacists are allowed to administer to children from January 1, 2023, to January 1, 2025. This change effectively includes newer mRNA vaccines like Spikevax and Comirnaty, which have been associated with an increased incidence of myocarditis, particularly among young males.
