We are a national small business organization that empowers America's diverse entrepreneurs to build a thriving and equitable economy. With a network of more than 85,000 small businesses and 1,500 business and community organizations we help deliver resources to entrepreneurs and advocate for public policy solutions that promote inclusive small business growth.At Small Business Majority, we know that small businesses are the heart of America and nowhere is that more evident than in Missouri, where they make up more than 99% of all businesses in the state. Unfortunately, Missouri businesses of all sizes are facing an ongoing labor shortage with 53 available workers for every 100 open jobs. This has an enormous impact on the state's workforce and economy. This labor shortage is further exacerbated by the reality that 1 in 3 American adults—and nearly two million Missourians - have some form of a criminal record. For these individuals, having a record—even when it is decades-old - can present significant barriers to meaningful employment, housing, education, occupational licensing, and other critical services. It can also severely limit a person's ability to start a new business. As employers seek to fill these vacancies and Missouri looks to strengthen its economy, we should be working to ensure that people who want jobs and are ready to work can enter the workforce. Clean Slate would help remove unnecessary barriers, and small business owners across Missouri would benefit. In 2022, we polled small business owners across the country, and found overwhelming support for reforms that would remove barriers to employment or entrepreneurship opportunities for formerly incarcerated individuals. In fact, 84% of small business owners agreed that Clean Slate policies would open up a pool of applicants that have earned a second chance. This would benefit small businesses in their efforts to hire and recruit employees by tapping into a vast, underutilized and productive workforce. The impact on employment prospects and earning potential can also hardly be understated. A study in Michigan found that automatic record sealing increases wages by more than 20 percent within one year alone; without being burdened by a criminal record, justice-impacted individuals can earn significantly more. Further. employers who hire justice-impacted workers consistently report that their turnover rates are notably lower and the quality of work of individuals who have a criminal record are on par with or better than their peers. For small business owners, these benefits are anything but small. Clean Slate would help small businesses flourish, all while bolstering the workforce and strengthening the economy. My name is Danielle Campbell. I grew up in Grain Valley, MO with my mom and dad, My grandparents lived down the road and we visited them often. I was on the honor roll and actively involved with sports. In 2016, I ended up in prison on a possession charge. My felony should not define me. If I had a "clean slate" this could eliminate barriers that I continue to face even though I have served my time in the Missouri Department of Corrections. I am now a case manager at Journey to New Life, helping other men and woman who are released from prison. I support my clients with reentry life skills, housing support, advocacy, financial literacy, etc. Currently in Missouri the expungement process is expensive and difficult to navigate, shutting out people with low incomes who already qualify for a 2nd chance. Under our current system, those with money or powerful connections are treated differently than everyone else. If we can automate the process, it will even the playing field for everyone. I make 45k per year and things are very tight with paying market rent \$900, \$100 utilities, \$100 food, \$500 car payment, \$150 insurance, just to name a few. Clean Slate offers someone like me a life that would NOT be defined by their worst mistake, and those who have completed their sentence and stayed out of trouble with the law deserve a second chance. I have paid my debt to society and should not be punished forever by being denied jobs, housing, and the opportunity to be an active member of my community. If it weren't for Journey to New Life, I wouldn't come close to making a livable wage. Like so many of my peers, we are not being given opportunities to be successful. Employers are defining who we are based off our past and not willing to hear the strives we've made to better our lives. This is also the case with landlords, I was denied housing through multiple properties from a felony possession charge I got in 2011.

I urge the committee to support HB 953 because it preserves the integrity of our justice system by returning the sentencing in a capital murder trial to the jury, not a judge, when the jury does not reach a unanimous decision. Missouri has been an outlier in capital murder sentencing when the jury is not unanimous. In the capital murder sentencing case of Craig Wood in Greene County about 10 years ago, the jury did not reach a unanimous sentence. Judge Tom Mountjoy decided Mr. Wood should be sentenced to death. Notable in this case is that the victim's family did not want to pursue a death sentence, but Greene County Prosecutor Dan Patterson went against their wishes and sought death. Mr. Wood received the death sentence due to the actions of two people--the County Prosecutor and the judge. Abolishing the loophole of a judge deciding the sentence in a capital murder case when the jury is not unanimous would legally provide justice in sentencing, because the sentence would be handed down by the jury, not the judge. Three of the five people who are eligible for execution in Missouri received their death sentence because of this loophole. This is outrageous. Please abolish this loophole.

I am writing today in support of Bill 953. This bill represents an opportunity to ensure that the hard work of juries in Missouri is not undermined by the judicial process- especially when addressing the most difficult cases, those involving capital punishment. Judicial override is undemocratic and unconstitutional. It undermines the role of the jury in imposing the ultimate punishment. In federal death penalty cases and in all other states besides Missouri and Indiana, a deadlocked jury results in an automatic sentence of life without parole. Current Missouri statute § 565.030 (2013) allows a judge to impose a death sentence without a unanimous jury verdict. When a jury cannot reach a unanimous verdict for life without parole or death, the statute states that the judge will assess the mitigating and aggravating evidence and then choose between life without parole or death. Unconstitutional under the Sixth Amendment: the U.S. Supreme Court has ruled that the Sixth Amendment requires a jury, not a judge, to find each fact necessary to impose the death sentence. Juries should have the final say on whether to impose the death penalty or life in prison in capital murder cases. Death sentences by judicial override will lead inevitably to expensive litigation through the automatic death penalty appeals process, only to possibly be overturned for life without parole. The automatic death penalty appeals process takes an average of 15 additional years. This is traumatizing to victim families, who must relive the events of the crime repeatedly for decades. Note: in the Craig Wood case the victim's mother had publicly requested life without parole. The judge thus sentenced her along with the defendant to go through the whole death penalty appeals process. Coincidentally, Craig is back in Greene County this week for an evidentiary hearing on a motion to vacate his death sentence. Since 2013, only one jury has voted unanimously for death and resulted in a death sentence, that was in St. Charles County in 2022. Of the four deadlock juries since 2013, two resulted in death- Marvin Rice and Craig Wood.In 2003, In State v. Whitfield, The Missouri Supreme Court invalidated the death sentence, finding that the Sixth Amendment right to trial by jury requires that the jury determine the facts necessary to render a defendant eligible for a capital sentence. Section 565.030.4 of the MO Revised Statutes, the statutory section articulating a four-step process for the imposition of a death sentence, could not be undertaken by a Judge. "This process clearly violated the requirement of Ring that the jury rather than the judge determine the facts on which the death penalty is based." Our court further observed, "Not just a statutory aggravator, but every fact that the legislature requires to be found before death may be imposed must be found by the jury."Ring v. Arizona, 536 U.S. 584 (U.S. 2002). U.S. Supreme Court invalidated Arizona's capital sentencing scheme, holding that the Sixth Amendment requires a jury to find the aggravating factors necessary for imposing the death penalty. Hurst v. Florida, 577 U.S. (U.S. 2016). U.S. Supreme Court struck down Florida's capital sentencing statute, where jury's determination amounted to an advisory sentence of life or death and the Judge made the final decision on sentencing. Following this decision, the Florida Supreme Court held that a death sentence must be issued by a unanimous jury. Missouri is an outlier, not only in executions, We are one of only two

states that permit judicial override: Indiana and Missouri.In April 2017, Alabama repealed its judicial override statute. Lead Sponsor Republican Dick Brewbaker emphasized that electioneering should not play a role in decision-making in capital cases. In Alabama, judges are elected, just as they are in Missouri. According to a report by the Equal Justice Institute one judge had noticed that he sentenced 3 black men to death, in light of he re-election he realized he needed to sentence a white person to death, and he did. Brewback found that overwhelmingly, the majority of judges preferred for juries to hold the ultimate decision-making power, as envisioned by the Constitution. According to a recent Pew poll, the death penalty is a punishment most of the US has deemed archaic and barbaric, and unnecessary for public safety. If Missouri desires to continue to make its citizens complicit in state murder, we should honor and recognize the constitution which requires sentencing by a jury of peers. Good afternoon Chairwoman Gallick. Vice Chair Thompson, ranking member Johnson, and honorable members of the Economic Development Committee. My name is Fran Marion. I'm a shift manager at Wendy's in Kansas City, MO, and I've been a fast food worker for over 20 years. I'm also a single mother of 2 young adults and a leader with the Missouri Workers Center, I'm here today to testify in favor of HB 953, the Clean Slate Initiative.I got arrested in 2009. I was working at McDonald's, making \$8.50/hr. On the poverty wages McDonald's was paying me we struggled to keep up with the bills. We fell behind on our electric bill and got our lights cut off. For a little while, we were able to run an extension cord from our neighbor's house so we could charge our phones, cook, and the kids could take a bath with warm water. But eventually we wore out our welcome and couldn't do that anymore. Worried about my kids, I resorted to cashing a bad check for \$700. It would have been just enough to pay our light bill and get our electricity turned back on. But as you can probably guess, that's not how it went down. The day I tried to cash the check, I got arrested right then and there. I spent 6 years in a state penitentiary for trying to keep the lights on for my family. That's 6 years of missed birthdays and holidays with my kids, and watching them grow into young adults, that I can never get back. Can you imagine missing that much time with your kids when they need you most? When I got out, I went to the halfway house and they gave me a list of places that would hire people with a record: fast food restaurants and low-wage warehouse jobs. The same jobs that had trapped me in poverty before. I ended up at Popeye's where I worked for 7 years. And I have been trapped in low-wage jobs ever since. I have always worked. But, I have been stuck in low-paying jobs — sometimes more than one at the same time — where me and my coworkers are creating BILLIONS of dollars in wealth for corporations that don't even pay me enough to feed my kids. We have been homeless, we have had our lights and water cut off. It doesn't have to be this way. After 7 years at Popeye's, I knew that store like the back of my hand, but I was denied a promotion to become a shift leader because I committed a crime of poverty almost 2 decades ago. And I can't tell you how many times I have been denied housing for the same reason. Me and my kids have been forced to live in unsafe housing because of my record. No matter how hard I work, I don't feel any less trapped. Society continues to punish me with a LIFE SENTENCE where my record is on me like a scarlet letter. No matter who we are — Black, white, or Brown — we make mistakes. We all deserve to move on in life when we make amends. Isn't that what being human is about?Right now. 518.000 Missourians like me are already eligible for expungement. but less than 1% of us actually get our records expunged because the process is too difficult, timeconsuming, and expensive. I'm here today to ask you to cut the red tape and make expungement automatic so we can finally have the clean slate we deserve. Please vote YES on HB953. Thank you.

Today, I write to you incontinued support of Clean Slate Missouri, HB 953.In 2012, I started SugarBot because I wanted to have more control over the products Imade, and enable myself to do business in a way that aligned with my personal values. Inmy 13 years of business ownership, I have grown and supported the community throughacquisition of two other small businesses, and have purchased, fully rehabbed, and continued to maintain two key historic buildings in St. Charles, Last year, SugarBot washonored to have received the "Grow St. Charles" award, which is presented to a businessthat has made meaningful contributions to the city based on their impacts on theenvironment, community, innovation, and employee programs. I am deeply proud of thework I have done in St. Charles, and the work I will continue to do within my business and the greater community. Sugar Bot exists to be a place for families, for celebrations, for sharing. Above all, we are abusiness that believes in empowering folks to do better for not just the ones they love, butalso for themselves. Unfortunately, for the approximately 1.9 million Missourians who havesome form of a criminal record, these basic human experiences are often out of reach alldue to a mistake made, sometimes decades, in the past. Everyone knows someone who has made a mistake they regret and then learned from theiractions. I strongly believe that folks deserve second chances and I believe that everyonereading this can remember a time in their own life that they were the recipient of a secondchance - perhaps one that even changed their life. When it comes to second chances, I don't say these things in a hypothetical sense; atSugarBot, we actively employ folks with felony convictions, as well as those who have grownup in the prison pipelines that continue to exist in the state of Missouri and beyond. In myprior testimony, I shared details of the first employee, who was released after serving 36years in prison and we were lucky to hire through St. Louis University's TransformativeWorkforce Academy. After accepting the offer, he was promoted three times in less than twoyears, quickly becoming our absolute favorite employee to work with. I am happy to sharethat he is still employed with us today. I would like to also share that we, at SugarBot, continue to offer positions to those rebuilding their lives from much less severe crimes -including those that would be impacted by the passage of Clean Slate. Unfortunately, inmany instances, those we offer a position to have been unable to accept employment due to the logistical impediments as a result of their convictions. On several occasions, I'vewitnessed individuals who are ultimately forced to decline the offer due to housing andtransportation limitations, despite the fact that many live within the same county where mybusinesses preside. Additionally, I continue to spend my precious and limited time as a mentor for

othersparticipating in the program with job coaching, skill building, and resume writing. I amdedicated to supporting those who are helping themselves, and continuing to directly witnessthe vast pool of talent that wants so badly to rejoin society and make right the wrongs thathave been committed. While I understand that Clean Slate will not help everyone that we are able to employ, itaims to help the thousands of individuals who we do not have open positions for findmeaningful employment elsewhere. It will also help folks build the lives they have worked sohard to regain. Additionally, it would help those we are able to employ accept and celebratea more dignified return to the workforce, and to the community as a whole. Passing Clean Slate legislation would help remove barriers for so many who have turnedtheir lives around, and have earned this chance. This bill would allow individuals withcriminal records to access employment, housing, education, and more. Even as more andmore employers are turning to Second Chance Hiring, like we did at SugarBot, systemicchange is essential to fully allow individuals with old criminal records to meaningfully andfully re-enter society. I am in strong support of this legislation, and I welcome you to reach out to me at any timewith questions, or to open further dialogue about my experiences in any way that may behelpful. As the largest and oldest anti-poverty advocacy agency in our state. Empower Missouri is committed to improving the quality of life for all Missouri residents through advocacy. Since our inception, Empower Missouri has focused on the criminal justice system and its impacts. Our Community Justice Coalition consists of community advocates and organizations from across the state who work with those who have been impacted by the criminal justice system. Many coalition members are formerly incarcerated or have currently incarcerated loved ones, and all are connected by a vision for a future without mass incarceration. We are thrilled to offer testimony in support of SB 19, which we'll be referencing as Clean Slate legislation. Our nation's criminal justice system was conceived and implemented long before the internet became an integral component of our society. The justice system was designed to both punish and rehabilitate people who break the law, serving as a deterrent for illegal activities and offering corrective supports to those who have broken the law out of desperation, due to mental illness or addiction, or as youthful indiscretions. Individuals are tried by a jury of their peers, and if they are found quilty, they are sentenced to a punishment that is commensurate with the level of harm caused to the community. The system was not designed to punish people for the rest of their lives. However, with the advent of the internet and online repositories for criminal records, this is the reality in which we currently live. Many individuals with past criminal records report years, even decades, of struggling to secure employment and housing due to the high prevalence of background checks conducted by employers and landlords. Nearly 9 in 10 employers use background checks in hiring; an estimated 4 in 5 landlords use background checks on prospective tenants; and more than 3 in 5 colleges and universities use background checks in admissions. In addition, an applicant with a criminal record is 50 percent to 63 percent less likely to get a callback or job offer than an identical applicant without a record; in turn, between 60 percent and 75 percent of formerly incarcerated individuals remain unemployed one year after their release. As a result, previously incarcerated people are 10 times more likely than the general public to end up homeless. With 1.8 million adults with a criminal record in Missouri, this has resulted in staggering poverty, with ripple effects extending beyond the individual and impacting families, communities and our society as a whole. The American Conservative Union's Nolan Center for Justice asserts that the harm done by a sentence should never be greater than the harm caused by a crime. But records for offenses like drug possession, writing a bad check, or petty theft can amount to what feels like a life sentence of being denied jobs, apartments. access to loans, and other collateral consequences for past mistakes. Clean Slate is important because it ensures that punishments fit the crime and have a clear end date, rather than lingering for a lifetime. When we continue to punish people for years or even decades for previous mistakes, we drastically hinder people's ability to provide for themselves- forcing them onto social safety net programs or back to criminal actions that send them back to prison- both which come at a high cost to taxpayers and society as a whole. In 2012, Missouri began to recognize the unintended consequences

that these criminal records were having on individuals and communities and implemented an expungement process that would allow individuals to have their records sealed from public view, while remaining accessible to law enforcement. Unfortunately, after a decade's worth of implementation, we have come to understand that the current process is cumbersome, complicated and costly. As a result, less than one percent of Missourians who are eligible to have their records expunged are actually able to achieve those expungements. This is clearly not having the intended impact, and we are proud to support Senator Trent and Senator Williams' proposals to automate the process so that everyone who has earned the opportunity for a Clean Slate is provided that second chance. Under this system, an algorithm that is coded to eligibility criteria runs a monthly search on the state's criminal history database and routes the list of eligible records to the courts for processing. Automating the process makes it accessible to all Missourians, regardless of whether they have the knowledge, time, and resources to navigate a complicated, costly system over many months or even years. However, expungement would remain unavailable to those who have committed violent or sexual offenses, and individuals would still have to meet a number of standards to qualify for this automated process. Individuals must serve their full sentence, pay any restitution to victims in full, and remain crime-free for several years. (Individuals who remain crime-free three to four years after a nonviolent conviction are no more likely to recidivate than the general population is to be arrested.) And the opportunities that Clean Slate provides—making it easier to get a job, find stable housing, and go back to school-make it even less likely that a person will commit another crime, aiding all of our efforts to create safer communities.We also know that Clean Slate makes good business sense. It is estimated that the underemployment of formerly incarcerated job seekers costs the US economy more than \$78 billion annually. Preliminary research from Michigan finds that recipients of record sealing saw an 11 percent increase in the probability of employment and a 22 percent increase in quarterly wages in the first year. It will help to rebuild our workforce and communities post-pandemic, driving inclusive economic growth. Missouri employers are desperate to fill positions left open by worker shortages across our state. We can help by adding tens of thousands of Missourians back to the workforce with Clean Slate, allowing them the opportunity to provide for their families. Employees with criminal records in the private sector have longer average tenures than employees without records, are less likely to leave voluntarily, and are no more likely to be terminated involuntarily. For these reasons, a 2022 report from the Missouri Chamber of Commerce & Industry entitled Safer Missouri, Stronger Missouri, touted the value of expungements in putting Missourians back to work. There have been some concerns about the implementation of Clean Slate in light of how burdensome the "automatic" expungement of marijuana-related offenses has been under Amendment 3. Two measures have been taken to ensure that the implementation of Clean Slate looks very different. First, there is clarifying language this year that specifies that automated expungement only applies to digital records—this means that the records can be identified and expunged more efficiently with the use of data and technology. In other words, this means there won't be a need for court clerks to dig through storerooms looking for historical paper records. Second, the outlined process in these bills has a staggered implementation timeline—three years to start the new expungement process, and two more years to finish expunging retroactive records. That means the agencies will have a total of five years before current records need to be expunged, which is much more time to implement the policy than the mere months that Amendment 3 offered. Everyone wants this bill to work in the real world, both for people who will gain access to jobs, housing, and other opportunities—and for the court and law enforcement staff that will be implementing it. Proponents of the bill are eager to incorporate feedback from the agencies that will make the bill more efficient for them to carry out.We all know people who have made mistakes and worked to turn their lives around. They want to find a job and a good home for their children. They want to go back to school and get the degree that could help them advance. They've already paid their debt to society, but their record creates never-ending barriers to their success. They have earned a second chance, and we have the opportunity and the obligation to extend it to them- for the common good.

Clean Slate automation ensures that all Missourians, regardless of resources or knowledge, can navigate the expungement process without enduring a complex, costly system. While individuals convicted of violent or sexual offenses remain ineligible, those who have served their full sentence, paid restitution, and remained crime-free for several years can benefit. Research shows that individuals who stay crime-free for three to four years after a nonviolent conviction are no more likely to reoffend than the general population. By removing barriers to employment, housing, and education, Clean Slate reduces recidivism and promotes safer communities. Additionally, addressing underemployment among formerly incarcerated individuals could boost the economy, with studies showing expungement leads to increased employment rates and wages. Missouri employers facing worker shortages would benefit from adding tens of thousands of qualified individuals back into the workforce. Concerns over implementation challenges have been addressed to ensure Clean Slate runs efficiently, unlike the burdensome expungement process for marijuana-related offenses under Amendment 3. The bill specifies that only digital records are eligible for automated expungement, allowing technology to streamline the process without requiring court clerks to manually sort through paper records. Additionally, a staggered timeline grants agencies five years to implement the policy—three years to begin and two more to complete retroactive expungements—offering far more preparation time than Amendment 3's rushed rollout. Lawmakers are committed to making this bill effective for both individuals seeking a fresh start and the court and law enforcement agencies responsible for its execution. Feedback from implementing agencies will continue to refine the process, ensuring the bill's success in both policy and practice.

I urge you to support HB953 (Davidson), which offer Clean Slates to our neighbors with criminal records who are eligible for expungement but are unable to access it. Automating the record clearing process is good for our community and our neighbors. Our communities thrive when people have access to basic human needs, and a past record should not prevent our neighbors from accessing housing, better paying jobs, recreation, and volunteer opportunities. Criminal records should not be a life sentence. Current Missouri law recognizes that by allowing the expungement process for up to three misdemeanors and a felony. However, we understand that the current petition based process is cumbersome and expensive, meaning only the richest and most connected of our neighbors are able to access expungement. Fewer than 1% of eligible people are able to access expungement, despite its life changing potential. Missouri is a state which values hard work and growth. Records keep folks trapped in their past bad choices, instead of celebrating change. Automating record clearing levels the playing field, allowing people to move on from mistakes. People with cleared records are less likely to commit another crime, helping to keep our neighborhoods safer. With over 1.9 million adults with records in Missouri, the time is now to clear as many records as possible. Our communities struggle to fill jobs. A person with a past criminal record may be the perfect candidate, but unable to access this job because of a past charge. Within one year of record clearing, people are 11% more likely to be employed and earn an average of 22% higher wages. Our friends, family members, and neighbors deserve a true second chance through automated record clearance. We urge the Missouri state Legislature to pass legislation to implement record clearance in Missouri as soon as possible. We have waited long enough. In addition, the bill repeals provisions that allow judges to assess the death penalty without the unanimous decision of a jury. This judicial loophole means that when there is a hung jury in the punishment phase of a capital case, meaning the jury cannot unanimously agree to one sentence or the other however, the courts have said the judge can then make the decision and sentence the defendant to life without the possibility of parole or to death. The current statute states "the jury shall be instructed before the case is submitted that if it is unable to decide or agree upon them punishment the court shall assess and declare the punishment at life imprisonment without eligibility for probation, parole, or release except by act of the governor or death." The intent of the original language was to specify that the defendant cannot be released from their imprisonment except by a Governor's pardon or when they die, and that the default sentence when the jury is hung is life without parole. A court interpretation of the plain language of the statute granted the ability to sentence the defendant to death in the case of a hung jury to a single judge by adding a comma into the sentence that doesn't exist. This interpretation undermines the power of the jury, a critical component of our legal system. To close this loophole, these bills would remove the "or death" language in the statute, requiring the judge to sentence the defendant to life without the possibility of parole in the case of a hung jury. This simple change would place the power of sentencing back into the hands of

the jury of our peers instead of one person. According to data from Missourians Against the Death Penalty (MADP), since 2002, five people have been sentenced to death by an individual judge's decision after a jury couldn't make a unanimous decision during the weighing procedure: Deandre Buchanan (2002), Amber McLaughlin (2006), Lance Shockley (2009), Marvin Rice (2017), and Craig Wood (2018). The current court-assigned death penalty loophole presents significant ethical and judicial concerns. Primarily, this practice can unduly influence the jury's decision-making process, coercing them towards a consensus out of fear that their inability to agree might directly lead to the death penalty. This scenario puts undue pressure on jurors, potentially swaying their judgment towards a guilty verdict or a specific punishment, not on the basis of evidence or moral conviction, but on the apprehension of indirectly causing a death sentence. Such a provision undermines the integrity of the jury system, which is designed to reflect impartial community standards and values in the judicial process. Repealing this provision could restore the jury's role as an impartial body meant to deliver justice based on evidence and legal principles, free from undue influence regarding sentencing outcomes.

Since its inception, RBIJ has collaborated with companies of all sizes across two dozen states to advocate for practical policy reforms that expand workforce opportunities and stimulate economic growth. Today, we proudly stand in support of the passage of HB 953 (Clean Slate), legislation that is good for business, good for the economy, and good for Missouri. Approximately 1.8 million Missourians have some form of a criminal record. For many, this poses an enormous obstacle to a person's employment, occupational licensing. housing, and educational prospects — all of which directly impact one's ability to earn a stable living and support themselves and their families. When it comes to employment, in particular, the obstacles are especially onerous: nine in ten employers currently use background checks to screen applicants, and having a record — even one that is extremely old or unrelated to the job — reduces an otherwisequalified job seeker's chance of getting a callback by nearly 50 percent. While hundreds of thousands of Missourians are eligible to have their records sealed right now, the existing petition-based system is costly, complex, and time-consuming - so much so that less than 1% will complete the process. In practice, that means that many Missourians are being denied the relief - and the economic opportunities - they deserve. This has an enormous impact on Missouri's workforce and economy. As labor shortages persist, businesses of all sizes are struggling to fill open positions, with thousands more job vacancies than available workers. In Missouri, I've heard directly from local employers that they desperately need access to a wider talent pool. Excluding eligible workers just because they have an old criminal record is holding employers back. Clean Slate would also save taxpayer dollars and strengthen our economy. The U.S. loses an estimated \$87 billion in GDP per year due to the underemployment of formerly incarcerated people. Conversely, when people have their record sealed, their wages increase by an average of 22% within one year — which means more money back into our economy. By helping individuals with old criminal records get back into the workforce, we would also make Missouri safer. Stable employment is one of the most effective ways to reduce recidivism; without fair access to the workforce, individuals with records — and their families — are likely to become stuck in cycles of unemployment, poverty, and recidivism. There is a reason Clean Slate enjoys support from Missouri entrepreneurs and small business owners, mid-size and large companies, and a cohort of the state's most influential chambers. They understand what's at stake: a stronger workforce, a growing economy, and prosperous communities where they live and operate. We thank the sponsors of this important legislation and urge the legislature to pass Clean Slate. HB 953.

Women's Voices, founded in 2005, is a nonpartisan organization of more than 300 St. Louis area members with 4469 social media subscribers. Our mission is two-fold: education on a wide variety of issues through free public programs, and advocacy through our members' and subscribers' activities in the community. Our interest in Clean Slate initiatives began four years ago when we hosted a program that focused on reentry services for formerly incarcerated people in the St. Louis area. It was eye-opening to learn of the many obstacles that people returning to our communities face because of a criminal record, no matter how minor. We listened to the life stories of people who have struggled and even succeeded, but who still carry the heavy baggage of criminal records. Simply put, people continue to pay for the same crime over and over, rather than being able to move on, enhance their lives, and contribute to society. We asked ourselves where is the balance between punishment and ruining lives? And if Missouri's laws provide for expunging certain criminal records, why weren't more people seeking and receiving relief? We subsequently learned that 98-99% of those eligible for expungement are unable to navigate or afford the current petition process, leaving half a million Missourians with criminal records that the law already says can be expunged. This is neither fair for individuals and their families, nor desirable for our communities. Continuing to effectively bar ex-offenders from employment and housing makes zero sense and is a recipe for recidivism. Nationally, and in Missouri, recidivism rates are in the 60-70% range. But states that have cleared people for expungement have seen recidivism rates drop to 20-30% and lower. Moreover, studies show that ex-offenders who have remained crimefree for 3 to 5 years are no more likely or even less likely than the general population to commit a crime. We researched national and state Clean Slate initiatives and later joined the Missouri Clean Slate Campaign as a partnering organization. Since 2018 twelve states, recognizing that 25% to 40% of their adult populations were similarly hindered by criminal records, have enacted Clean Slate legislation with wide bipartisan support. Pennsylvania, the first state to adopt automated expungement, has expanded expungement eligibility two times after having already sealed the records of 1.2 million people. In Philadelphia more than 1,000 formerly incarcerated people who had their records expunged through gubernatorial pardons were followed for a decade by two studies, one on recidivism and the other on economic benefits. The studies\*, published in 2020, revealed an extremely low (1%) rate of recidivism and impressive economic benefits to individuals and neighborhoods. They concluded that

increasing expungements could provide a no-cost economic investment across the state, especially in areas most in need of growth, and that there were no public safety concerns. We are grateful to Representative Davidson for introducing House Bill 953. We firmly believe Clean Slate legislation is smart on crime, makes good business sense, and will boost local and state economies for the following reasons: Many of the half million eligible individuals will have the opportunity to earn a decent living, obtain stable housing, and provide for their families. **Employers will be able** to expand their workforce with qualified people eager and able to work. Missouri will save taxpayer dollars by bringing more people into the workforce and interrupting the cycle of recidivism and reincarceration. The stigma of a criminal record is a major driver of poverty, which in turn is the strongest predictor for recidivism and the cycle of reincarceration.. Communities will be safer due to lower recidivism rates as more people are able to move on with their lives and provide for their families. A criminal record should not be a life sentence to poverty. We firmly believe it is in our community's best interest to have healthy, self-sufficient individuals and families who, with obstacles removed, are more likely to engage in their neighborhoods, seek more education, volunteer at their children's schools, and pay taxes. We add our voices to those who believe a Clean Slate Act will provide both help and hope to the half-million Missourians who are currently eligible for record expungement. I would like to call attention to two studies that followed more than 1,000 formerly incarcerated people in Pennsylvania who had their records expunged through gubernatorial pardons. These studies covered the decade from 2008 to 2017, and preceded and supported the passage and implementation of Pennsylvania's Clean Slate Act in 2018. The economic development study found impressive economic benefits to individuals and neighborhoods, and it concluded that finding ways to increase expungements could provide no-cost economic investments across the state, especially in areas most in need of growth. The parallel recidivism study of the same individuals found a stunningly low level of recidivism over a 10-year period and satisfied public safety concerns. Thank you for allowing me to testify. I ask that this bill be sent out of committee with a "Do Pass" recommendation.

My name is Shawntelle LaNette Fisher, Founder and CEO of The SoulFisher Ministries. The SoulFisher Ministries is a nonprofit organization with a mission to respond to the needs of youth with incarcerated parents and to promote restorative justice for those currently or formerly incarcerated. We accomplish our mission by providing after school tutoring and enrichment for students who have an incarcerated parent and reentry programs and services for currently or formerly incarcerated people. I am definitely in support of the Clean Slate Bill. My only concern is that those who receive the "clean slate" will still have their criminal record used against them. I am a highly influential community and business leader in St. Louis who also happens to be a convicted felon. I also the recipient of expungement. In light of this, my criminal record continues to be used against me because Missouri, in an effort to undermine efforts like expungement and Clean Slate, has enacted a State Statute that allows for governmental agencies you still use the criminal conviction against you. This statute is 210.1080. If you have ever PLED GUILTY to a disqualifying crime, it's used against you as a disqualifier for working with children. An example of this is seen in the ELIGIBLE letter that I received, in December 2019, from the Department of Elementary and Secondary Education to be a Director over the after school programs that I started and have led for 11 years. The eligibility letter is only good for 5 years. When I applied to have the letter renewed, I was informed that I am now INELIGIBLE to even be on site at any of my sites because the statute changed, not because I committed a new crime. The crime stems from a Suspended Imposition of Sentence (SIS) that I received for an assault charge 30 years ago when I had a fight with my boyfriend. Another example is when I applied to be a foster parent. My application was denied not because I am not qualified to be a foster parent, not because I don't have a safe stable home to foster children in, not because I can't financially care for foster children, but because of I PLED GUILTY to the crime 30 years ago. If crimes can be held against you as a collateral consequence of merely PLEADING GUILTY to a crime, it undermines the spirit of both expungement and the Clean Slate initiative.
