Good afternoon Chairperson Christ and members of the committee. My name is Troy Williams Mo Association of Veterans Organization ChairmanThe purpose of the Missouri Association of Veterans Organizations (MAVO) is for its members to assemble and exchange ideas for the collective welfare of all veterans residing in the state of Missouri, assist the Missouri Veterans Commission, and advise the Governor and General Assembly on matters of interest. Membership in MAVO shall be open to any state -wide veteran's organization operating in support of Missouri veterans, their families and survivors. Thank you for the opportunity to testify on behalf of Missouri veterans regarding this piece of legislation. I want to begin by expressing our appreciation for being engaged early in this process. We value the discussions we've had with the stakeholders here today who support this bill, and we are encouraged by the collaborative efforts to develop legislation that truly benefits Missouri veterans.?We are particularly interested in how this bill could addresses funding issues for the Missouri Veterans Commission and how it may impact individual posts and chapters across the state and their sustainability in serving their communities. The data shared with us shows that in states with regulated VLT programs, like the one proposed in this legislation, local VFW, DAV, and American Legion outposts have generated significant revenue. This type of program could provide our outposts with similar opportunities to generate substantial funds to support the posts and their communities. These local outposts support numerous charitable causes, youth programs, and veteran's support programs, and they are vital to their communities and to Missouri veterans. Another component we like about this bill is that a substantial portion of the annual administrative fees charged on licensed VLT machines will generate \$10 - \$15 million per year, which will be dedicated to critical veterans causes in Missouri that are currently underfunded. This funding is critical to the survival of our veterans homes and cemeteries.Looking ahead, we will continue to have important discussions with these stakeholders at our MAVO meetings and VFW and Legion meetings across the state. In closing, we want to express our gratitude for the thoughtful consideration of our concerns and for the efforts being made to address these critical issues. Troy Williams MAVO Chairman
