This is why, even now, a person convicted of a sexual offense – sometimes even much less than the ones addressed in this legislation – must continue to register as such and they are not allowed to live within a certain distance of a school, and they cannot generally be in places where children are present. But even in that, consider the lady who is a victim of rape....trying to put it behind her, trying to live a normal life in spite of the struggles she faces within her own marriage. Then a sex offender moves into her neighborhood. Suddenly the home she fought so hard to attain in a neighborhood that was once safe is now – to her – a place of danger every time she goes out the door. Through no fault of her own, she is once again traumatized. Why should the violator be free when the violated is still imprisoned emotionally, psychologically, and socially? And as for those who are trafficking children....well, it should evident to all that they need to be imprisoned for life! There are those who are trying to use the term “minor attracted person”. They are perverts, that’s what they are. Manipulating, abusing, threatening . . . playing on the naivete of young minds and hearts. Actually, life-imprisonment is too kind for such people. Have you seen the movie “Sound of Freedom”? If not, I challenge you to watch it. It is available on a variety of platforms and streaming services. If we don’t do what is necessary to protect our children who will? HJR26 is necessary to protect our children. I urge you to vote “Do Pass” on HJR26.
