Allows SOS and legislature to stall signature gathering and certification of measures. While these versions apply only to legislatively referred referendums, an amendment to the senate version of the bill would include citizen-lead initiatives, which would give political actors near veto power to indefinitely draft biased or confusing language and block movement of citizen initiatives, indefinitely delaying the ability of citizens to gather signatures to get their measure on the ballot.. Violates separation of powers. Courts should have the ability to stop and correct illegal language that violates Missouri law.
