This act repeals such sunset.),section 135.775 (A tax credit for the sale of biodiesel fuels expires on December 31, 2028. This act repeals such sunset. This act provides that a taxpayer shall not be liable for penalties or interest on an income tax balance due if such taxpayer is denied part or all of a tax credit to which the taxpayer has qualified due to lack of available funds, and such denial causes a balance-due notice to be generated by the Department of Revenue or any other redeeming agency. Such taxpayer shall pay the balance due within sixty days or be subject to penalties and interest pursuant to current law.), and section 135.778 (A tax credit for the production of biodiesel fuels expires on December 31, 2028.
