By having constitutional protection, sheriffs can operate independently from political pressure and special interests, ensuring they prioritize upholding constitutional rights, including due process, equal protection, and freedom from unlawful searches and seizures
- **Checks and Balances:** Constitutionally protected sheriffs act as a vital check on potential abuses of power by other branches of government, including federal agencies or state authorities. They serve as a last line of defense against overreach, protecting citizens from potential violations of their rights by other government entities
- **Local Autonomy and Accountability:** Sheriffs are typically elected at the county level, which allows for direct accountability to the local community. Constitutionally protected sheriffs have the authority to enforce laws within their jurisdictions and are accountable to the citizens who elected them, promoting transparency and responsiveness to community needs and concerns
- **Defending Against Federal Overreach:** In instances where federal laws or policies may conflict with state or local interests or constitutional rights, constitutionally protected sheriffs can refuse to enforce or cooperate with mandates they deem unconstitutional or against the interests of their constituents. This serves as a crucial mechanism to protect states' rights and individual liberties
- **Preservation of Law and Order:** Sheriffs are responsible for maintaining law and order within their jurisdiction. Constitutionally protected sheriffs can uphold the rule of law while also respecting individual rights and liberties, striking a balance that fosters trust and cooperation between law enforcement and the communities they serve.

I have read SJR40 & I agree with all parts of this bill. The part that most concerns me is the part that pertains to the positive changes to be made to our Missouri Constitution, Section A, Section 6, Article X, to be repealed & replaced with a new Section 6, which reads as: "Section 6. 1. All property, real and personal, of the state, counties and other political subdivisions, and nonprofit cemeteries, and all real property used as a homestead as defined by law of any citizen of this state.... as defined by law...."As a senior citizen of 78 years old, I have a limited income of less than \$3,000 a month. That income includes Medicare & small incomes from my teaching career & my husband's military service. With that amount I have to pay my electric, phone & other necessary bills, & my food, doctor & prescription bills, home repairs, lawn care & a host of other necessary expenditures to keep well & safe. Should I have any hospital, home or car repairs, I would have a difficult time covering those expenditures. My property taxes that I paid last December were \$1,824.87 for my house & \$174.38 for my car. That was 2/3 of a whole months income for me. I had to readjust payments on other things to meet that one bill. I just received a \$4,000 rise in my assessed real estate taxes from Franklin County for next year. I'm very concerned about the rising governmental costs of owning my home & car. The government treats me like it's a treat for me to own my own home & car outright. My deceased husband & I have worked hard to finally become debt-free in the last year of his life & have diligently paid our taxes for over 60 years. I have never received food stamps or any other governmental assistance during my lifetime & am only currently receiving Medicare (which I paid into all my working life.) But I'm having a difficult time making ends meet just to keep from going into debt once again. SJR40 would greatly help me in this effort. It would assist all senior citizens who have worked hard during their productive lives & are looking forward to a peaceful retirement. I don't have to live a life of ease, but I do want my government to respect my age & my efforts to be a good citizen by taking nothing from them all the years I was able to work. Please pass SJR40 & tell seniors you respect & honor them & their service to this nation.
