1 2. (1) Notwithstanding the provisions of subsection 1 of this section to the contrary, 2 beginning with the 2023 calendar year, but ending on or before December 31, 2025, the top rate of 3 tax pursuant to subsection 1 of this section shall be four and ninety-five hundredths percent.

- 4 (2) The modification of tax rates made pursuant to this subsection shall apply only to tax 5 years that begin on or after January 1, 2023, but before January 1, 2026.
- (3) The director of the department of revenue shall, by rule, adjust the tax table provided in 6 7 subsection 1 of this section to effectuate the provisions of this subsection. The top remaining rate of 8 tax shall apply to all income in excess of seven thousand dollars, as adjusted pursuant to subsection 9 5 of this section.
- 10 3. (1) [In addition to the rate reduction under subsection 2 of this section, beginning with 11 the 2024 calendar year, the top rate of tax under subsection 1 of this section may be reduced by 12 fifteen hundredths of a percent. A reduction in the rate of tax shall take effect on January first of a calendar year and such reduced rates shall continue in effect until the next reduction occurs. 13

(2) A reduction in the rate of tax shall only occur if the amount of net general revenue 15 collected in the previous fiscal year exceeds the highest amount of net general revenue collected in 16 any of the three fiscal years prior to such fiscal year by at least one hundred seventy-five million 17 dollars.

- 18 (3) Any modification of tax rates under this subsection shall only apply to tax years that 19 begin on or after a modification takes effect.

Each reduction in the top rate of tax shall be by one-tenth of 26 a percent and no more than one reduction shall occur in a calendar year. No more than three 27 reductions shall be made under this subsection. Reductions in the rate of tax shall take effect on 28 January first of a calendar year and such reduced rates shall continue in effect until the next 29 reduction occurs.

(3) Any modification of tax rates under this subsection shall only apply to tax years that 10 begin on or after a modification takes effect. 11

12 (4) The director of the department of revenue shall, by rule, adjust the tax tables under subsection 1 of this section to effectuate the provisions of this subsection. 8 (2) Notwithstanding any provision of law to the contrary, the amount of any tax credits 9 reducing a taxpayer's federal tax liability pursuant to Public Law 116-136 or 116-260, enacted by the 10 116th United States Congress, for the tax year beginning on or after January 1, 2020, and ending on 11 or before December 31, 2020, and the amount of any tax credits reducing a taxpayer's federal tax 12 liability under any other federal law that provides direct economic impact payments to taxpayers to 13 mitigate financial challenges related to the COVID-19 pandemic shall not be considered in 14 determining a taxpayer's federal tax liability for the purposes of subdivision (1) of this subsection.

For all tax years beginning on or before December 31, 2025, if a federal income tax liability for a tax year prior to the applicability of sections 143.011 to 143.996 for which he or she was not previously entitled to a Missouri deduction is later paid or accrued, he or she may deduct the federal tax in the later year to the extent it would have been deductible if paid or accrued in the prior year.

5. For all tax years beginning on or after January 1, 2026, there shall be no federal income
 tax deduction for any individual or corporate taxpayer under this section."; and
