10 complete a one-time four-hour course of training on sea

11 and human trafficking as a condition of relicensure;

12 (b) The training may be conducted online, shall be

13 consistent with the guidelines established in section

14 210.1505, and shall be available at no cost to the

15 personnel identified in this section and all ambulance

16 services and fire departments. The training may be

17 counted toward elective topics as determined by

18 the department, provided that the content is approved

19 by the department as established by regulation.
