FISCAL ANALYSIS

ASSUMPTION

§§115.133 and 561.026 - Restores Voting Rights to Individuals on Probation and Parole

Officials from the **Office of the Secretary of State** assume the proposal will have no fiscal impact on their respective organization for this proposal.

In response to similar legislation, HB 847 (2025), officials from the **Department of Corrections (DOC)** assumed there was no fiscal impact on their respective organization.

Upon further inquiry, DOC stated in FY25, they averaged 53,000 offenders under supervision. Therefore, **Oversight** assumes there could be an increase in registered voters.

Oversight notes that the Office of the Secretary of State and Department of Corrections have each stated the proposal would not have a direct fiscal impact on their respective organizations. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note.

Officials from the **Platte County Board of Elections**, the **St. Louis City Board of Elections**, the **Jackson County Election Board** and the **St. Louis County Board of Elections** each assume the proposal will have no fiscal impact on their respective organizations.

Oversight does not have information to the contrary and therefore, Oversight will reflect a zero impact.

Oversight only reflects the responses that we have received from state agencies and political subdivisions; however, other local election authorities were requested to respond to this proposed legislation but did not. Upon the receipt of additional responses, Oversight will review to determine if an updated fiscal note should be prepared and seek the necessary approval to publish a new fiscal note. A general listing of political subdivisions included in our database is available upon request.
