Bill Summary: This proposal modifies provisions governing mailed notice to sewer district customers with unpaid charges.

FISCAL ANALYSIS

ASSUMPTION

§§249.255 and 249.645 – Notice of Unpaid Sewer Charges

Officials from the **Metropolitan St. Louis Sewer District (MSD)** state the proposed legislation will impact MSD to the extent it would reduce the postage expense relating to notices required to be sent to customers subject to potential shut-off of water services due to delinquent sewer bills.

The MSD has approximately 69,000 delinquent accounts that are eligible to receive notices. With a savings of \$5.30 per notice that amounts to \$365,700 in savings. It is unknown how many of these notices will be sent out annually, since the shut-off program will just be starting in 2026.

Oversight assumes this proposal is reducing the postage fee paid by sewer districts when sending out delinquency notices to customers by certified mail (\$6.08) to first-class mail (\$.78). This would result in a savings to the sewer districts of \$5.30 per notice. **Oversight** notes there is no aggregate, statewide data or central repository available for the total number of delinquent notices sent out by all sewer districts in Missouri nor are the various districts required to report the total number of notices issued to a state-level entity. **Oversight** will reflect a potential savings that could exceed the estimate provided by the MSD.

Officials from the **Department of Commerce and Insurance, Department of Health and Senior Services, Department of Natural Resources, State Tax Commission, City of Kansas City, Little Blue Valley Sewer District and Wayne County PWSD #2** each assume the proposal will have no fiscal impact on their respective organizations. **Oversight** does not have any information to the contrary. Therefore, **Oversight** will reflect a zero impact in the fiscal note for these agencies.

Oversight only reflects the responses that we have received from state agencies and political subdivisions; however, other cities, counties, county recorders, water districts and sewer districts were requested to respond to this proposed legislation but did not. Upon the receipt of additional responses, **Oversight** will review to determine if an updated fiscal note should be prepared and seek the necessary approval to publish a new fiscal note. A general listing of political subdivisions included in our database is available upon request.

FISCAL IMPACT – Small Business

Small businesses, also known as investor-owned businesses, that operate water or sewer systems may be impacted by this proposal. Missouri's Public Service Commission define these businesses as utilities serving 8,000 or fewer customer connections.

FISCAL DESCRIPTION

Currently if a customer or a public sewer district has three months of unpaid charges, the district must notify the customer by certified mail prior to disconnecting service. This bill allows for notification by first-class mail.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.


