ASSUMPTION

§590.100 – Peace Officer License Requirements

Officials from the **Department of Natural Resources, Department of Public Safety – Director’s Office and Missouri Highway Patrol, Department of Social Services, Missouri Department of Conservation, Kansas City Police Department, Phelps County Sheriff, Branson Police Department and St. Louis County Police Department** each assume the proposal will have no fiscal impact on their respective organizations. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

Oversight only reflects the responses that we have received from state agencies and political subdivisions; however, other local law enforcement agencies were requested to respond to this proposed legislation but did not. Upon the receipt of additional responses, Oversight will review to determine if an updated fiscal note should be prepared and seek the necessary approval to publish a new fiscal note. A general listing of political subdivisions included in our database is available upon request.

Senate Amendment 1

Oversight notes this amendment removes the provision that the director shall have cause to deny any application for a peace officer license or entrance into a basic training course when the applicant is not a citizen of the United States. Oversight assumes there will be no fiscal impact from this amendment.

Senate Amendment 2 (§§160.665, 170.315, 590.010 & 590.205 – School Protection Officers)

Officials from the **Department of Elementary and Secondary Education, Department of Public Safety (Missouri Highway Patrol and Office of the Director), Department of Social Services and Missouri Department of Conservation** each assume the proposal will have no fiscal impact on their respective organizations. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

In response to similar legislation, HB 805 (2025), officials from the **Washington School District** assumed the proposal adds to the discussions and decision-making that school boards, administration, parents, and the local community must have. The additional designation would cause the necessity of added FTE (full-time equivalent) staff members at approximately \$40,000 per FTE and \$3,000 in training and fees.

In response to similar legislation, HB 805 (2025), officials from the **Richland R-IV School District** stated annual stipend paid to employee to cover weapon, ammo, insurance, and clothing

\$2000 per employee. Three-week SPO classes registration and quarterly qualification requirements are \$5,000 per employee.

Oversight notes currently, school districts can designate teachers or administrators to be school protection officers. This proposal adds other school personnel to the list of employees a school district can designate as a school protection officer and allows designated school personnel the authority to carry a weapon on school grounds if such individual has obtained a concealed carry endorsement or permit. Oversight assumes there will be no additional costs to school districts as a result of the proposal; therefore, Oversight will reflect no impact in the fiscal note.

Oversight only reflects the responses that we have received from state agencies and political subdivisions; however, schools were requested to respond to this proposed legislation but did not. Upon the receipt of additional responses, Oversight will review to determine if an updated fiscal note should be prepared and seek the necessary approval to publish a new fiscal note. A general listing of political subdivisions included in our database is available upon request.
